County Board – The recommendations that will go to the County Board tomorrow to fill the CJMC citizen member vacancies are Xong Xiong, Executive Director of the Hmong Mutual Assistance Association and Pastor LeRoy Sua. Ms. Xiong has done victim advocacy work at New Horizons, as well as other roles in the community. Rev. Sua, a Nigerian native, has been active in the Monroe County criminal justice system and has done human rights work in the United Nations and other victim advocacy work.

The new County Board Supervisors are Monica Kruse, Chair of Health & Human Services Board and Thom Downer, Supervisor from District 19.

APPLICATION FOR OFFICE OF JUSTICE ASSISTANCE GRANT

Jane presented a letter of application that she would like the council to approve. The Office of Justice Assistance is asking for applications for a grant which would involve a process and outcome evaluation of the OWI treatment court. A.J. Meyer, a professor at Viterbo University, would be helping with the project. The cost of the project is \$25,000 and is a year long process. **MOTION** by Burke/Johnson to approve sending the letter. **MOTION** carried unanimously.
