## PUBLIC HEARING ON NOMINATION OF TOWN OF ONALASKA - ASBURY METHODIST EPISCOPAL CHURCH

Chair Twinde-Javner opened the public hearing on the Asbury Methodist Episcopal Church at 9:12 a.m. Gerald Monti attended on behalf of the property owner, the Town of Onalaska. King Holley asked if there were any plans to restore the building, and Monti replied that they were hoping for grants to restore both the exterior and interior. Discussion was held about the original construction. The public hearing was closed at 9:16 a.m. MOTION by Kooiman/Schuppel to nominate the Asbury Methodist Episcopal Church as a historic site in La Crosse County. Motion carried unanimously. Loomis excused.

PUBLIC HEARING ON NOMINATION OF TOWN OF ONALASKA - ASBURY CEMETERY
Chair Twinde-Javner opened the public hearing on the Asbury Cemetery at 9:17 a.m. Gerald Mondi spoke on behalf of the property owner, the Town of Onalaska, and stated the cemetery was founded in 1863, and is the burial site of five Civil War veterans. The cemetery is separated from the church by about five miles, but the Town maintains the property. The public hearing was closed at 9:23 a.m. MOTION by Kooiman/Sween to nominate the Asbury Cemetery as a historic site in La Crosse County. Motion carried unanimously. Loomis excused.

## DETERMINE RECIPIENT OF 2012 COUNTY GRANT

Applications for the 2012 County grant were received from the following: Bangor \& Area Historical Society, Ridge History Park, Onalaska Area Historical Society.
