- 2 options looking for grant funding.
  - 1<sup>st</sup> option: Soft landing gravel pad accessible during various water stages ~Est.
    1-5K
  - o 2<sup>nd</sup> option: Premier take out for Riverside ~Est. 50-60K
- Concern was expressed by public member regarding no fees charged to non-motorized boaters and safety of blue routes on Mississippi River.
- A motion was made by John Fisher to support idea of La Crosse River take out, Bob Seaquist seconded. Motion carried unanimously.

- Will continue to scour, but based on H2O levels moving → 3 year Statement of Intensions
  - Check with John Hendrickson if CORPS could do volunteer study (Marc Schultz).
- High priority projects?
  - o Can we add this to 2013
  - o Put on next month's agenda
    - State limits on minimum project cost
    - Can we do application in February under emergency request
