## **DEER DONATION PROGRAM UPDATE**

• Deer donations are down from last years' numbers in the surrounding counties. The only exception to this is Trempealeau. Since numbers are still being turned in, the State does not have a grand total.

### **UPDATE USDA-AHPIS**

• The wolf is officially delisted from the Endangered Species Act as of January 27, 2012. On that date, Michigan, Minnesota and Wisconsin took over management of the species according to each State's management plan. Landowners should contact Wildlife Services if they have damages because the damage needs to be verified and confirmed.

### **UPDATE WDNR**

- No issues have been reported in La Crosse County in regards to wolves. Four losses have been reported in Monroe County. Currently trapping is the favorable method of control over a hunting permit system.
- The Hixton Forest Hunt was a success. Everyone involved enjoyed the experience and there were many deer sightings. The hunt will be held again one more year.
- It's been two years since the Goose Island Hunt. This hunt will only be implemented again if necessary in the future.
