INFORMATIONAL: CHAD ERICKSON PARK/VETERANS POND

They have a work day scheduled in October to clean up the park. They have plans drawn up for a new walkway bridge which is partially covered. Rotarians are raising funds to put in handicapped accessible docks. Mr. Erickson is working with the DNR to dredge the pond and stock it.

APPROVAL OF 5311 (STRAP) TRANSPORTATION GRANT

The STRAP Grant which has funded rural transportation in the Town of Holland, Bangor & Rockland for five years will end December 31, 2012. Running Inc. has been linking the service with Public Transit in La Crosse, Onalaska, Holmen and West Salem. They are also the provider for Onalaska-Holmen-West Salem transit system. This has successfully extended the shared-ride service area to all six communities. Ridership has steadily increased and now provides an average of about 250 rides per month. This grant will enable the Aging Unit to continue to provide this rural transportation to the Town of Holland, Bangor and Rockland in 2013. The grant reimburses 61% of expenses leaving 39% for local match and fare box revenue. **MOTION** by Richmond/Ferries to approve the 5311 (STRAP) Transportation Grant. **Motion carried unanimously.**
