Gary Ingvalson stated that there are many financial institutions listed, so that throughout the year, if one of these institutions has a more attractive interest rate, authorization has already been given to use them. **Motion carried unanimously**. #### **RESOLUTION RE: CANCELLATION OF OUTSTANDING COUNTY CHECKS**

**MOTION** by Pedretti/Kruse to approve. Dave Lange indicated that there is one minor change. **MOTION** by Hampson/Plesha to add wording in the "Now, therefore be it resolved" clause, after "in excess of two years" to add "and such checks are hereby cancelled". **Motion on amendment carried unanimously** (Meyer excused). **Motion on amended resolution carried unanimously** (Meyer excused).

# 2013 BUDGET – FINAL HOUSEKEEPING AND DIRECTION TO STAFF FOR PUBLIC HEARING AND BUDGET ADOPTION

**MOTION** by Pedretti/Ebert to amend fee schedule, Account 48077, page 3, to delete the Farmland Preservation Fee of \$.50 per acre. Supervisor Pedretti explained that this is a difficult policy decision and that after many discussions with staff, as well as with Supervisor

Wehrs, they felt that this is not an advantageous time to be implementing a new fee that affects farmers. Supervisor Pedretti stated that there is already negative perception of the County by many farmers due to a range of issues including: the new Zoning Ordinance which impacts land use within exclusive agricultural districts and the conditional use permit requirement for a farm operation that exceeds 200 animal units (instead of the 500 animal unit state standard). Because towns have until the end of January 2013 to decide whether or not to accept County zoning, Supervisor Pedretti indicated that the controversy surrounding this new fee could add one more item that pushes a town to make that decision. And if a town opts out, they would need to devise their own Farmland Preservation Program, or farmers in that town would not qualify for tax credits under the Working Lands Initiative.

Supervisor Pedretti felt that if we give farmers this year to get more involved and make them more aware of the financial situation, possibly next year this fee could be implemented. There is a WTA (Wisconsin Town's Association) meeting on November 15<sup>th</sup> at 7:30 in the Town of Burns, in Bangor to discuss some of these issues.

**MOTION** to amend the original motion by Pedretti/Ebert to increase the County Property Tax Levy in the amount of \$24,000 to replace the revenue in the Land Conservation budget Org 1021, Acct 48077, if the fee is eliminated. **Motion on amendment passes on a 5/3 vote**; Nays were Plesha, Ebert, Hampson; (Meyer excused)

Motion on original motion as amended fails on a 6/2 vote; Nays were Burke, Veenstra, Hampson, Plesha, Kruse. (Meyer excused)

Steve O'Malley distributed an updated version of the 2013 Budget Changes/Corrections dated 10-31-12. The form included in the packets was dated 10-24-12. The addition is at the very bottom of the page and is for New Residential Permits charge for \$560.
