# **RESOLUTION RE: AUTHORIZING APPLICATION FOR GRANT THROUGH COUNTY CONSERVATION AIDS:**

La Crosse County Facilities Director and staff are authorized to act on behalf of La Crosse County to: Sign and submit an application to the WDNR for any financial aid that may be available; to submit to the WDNR reimbursement claims along with necessary supporting documentation within one (1) year of project end date; and to take necessary action to undertake, direct, and complete the approved project; and La Crosse County will comply with all state and federal laws related to the County Conservation Aids programs and will obtain approval in writing from the WDNR before any change is made in the use of the project site. La Crosse County has budgeted \$25,000 in 2022 for the development of a canoe/kayak launch at Goose Island County Park and this grant would help to offset those costs. **MOTION** by Freedland/Padesky to approve. **Motion carried unanimously**.

#### APPROVE 2022 EQUIPMENT LIST

The Highway Commissioner indicated that this is the yearly equipment replacement budget, and the total 2022 budget request is \$2,414,000. There are 10 pieces of equipment in the schedule that is attached in the agenda packet. The Highway Commissioner recommends approval. **MOTION** by Nikolay/Padesky to approve. **Motion carried unanimously.** 

#### 2022 BUDGET REVIEW

Steve O'Malley introduced Jane Klekamp as the one that would be speaking on the 2022 budget review. To expand on her experience, Steve assigned both the Public Works and the Planning, Resources and Development departments to report directly to Jane in the last year. Steve spoke on the experience Jane has with courts and human services, stating she is now busy with all the departments that report to this committee and indirectly to Steve. To demonstrate that knowledge and teamwork in budget preparation, Jane presented the highlights of the departments that report to this committee.

- **Facilities**, **Page 86**: Requesting an increase for a maintenance manager position that became vacant when Ryan Westpfahl became the Facilities Director.
- **Special Jail Assessment**, **Page 312:** Part of the fees and fines collected by the court system is used to maintain the jail budget. The county uses this towards the

improvement of the jail or for costs that are related towards educational and medical services.

- Solid Waste, Page 439: There is an increase in budgeted revenues based on historical data.
- Household Hazardous Materials, Page 453: Each municipality is charged a fee for HHM at a rate of \$1.50 and then the county charges municipalities \$1.50 for each person, therefore each person is charged a county rate and a municipality rate and there is an agreement in place for those services. This is a joint operation between the County and the municipalities that is funded with property tax levy.
- **Highway**, **Page 456**: There is a decrease in one utility worker and an increase in a half-time custodian that will be paid for out of the machinery fund.

# Public Works and Infrastructure Committee Monday, November 1, 2021 LEC Boulevard Project Update

Subject: Update on LEC Boulevard Project

At the PWI meeting on Monday, August 9<sup>th</sup> the committee approved the LEC Boulevard Project to be awarded to Winona Nursery. Winona Nursery then went to the City of La Crosse to obtain a permit for the work and we learned that the project would have to be approved by the Parks and Recreation Board before that permit would be issued. The Parks and Recreation Board meets once a month, so we had to wait until the October 21<sup>st</sup> meeting to get on their agenda. Ryan Westpfahl attended the meeting virtually where the project was approved as presented. As we are now into colder weather, Winona Nursery has suggested that the project wait until the spring of 2022 to avoid stress on the new plants due to frost. The funds will be carried forward in March of 2022 to allow for the project to proceed as soon as the weather allows next spring.

- Approve WisDOT Discretionary Maintenance Agreement for Bridge Repair Material– WisDOT is offering us a \$10,530 Discretionary Maintenance Agreement to purchase and stage 530 tons of Heavy Riprap. This riprap will be used for future bridge slope repair work. This is a revenue contract for the Highway Department, I recommend approval, and request approval for the Highway Commissioner to sign WisDOT contract when received.
- Approve the 2022 WisDOT Routine Maintenance Agreement This is the contract under which the Highway Department performs State Highway Maintenance services for WisDOT within the boundaries of La Crosse County. This is a revenue contract for \$2,108,200, which is the same monetary commitment as the 2021, I recommend approval, and request approval for the Highway Commissioner to sign WisDOT contract when received.
- Approve the 2021-2022 Salt Bid. This is a WisDOT negotiated Bid. Cost is \$66.50 per ton. We will be purchasing 3,000 ton for the season. I recommend for approval.

Such payment shall be made upon presentation of accounts itemized and verified in accordance with regulations of the Department.

In connection with the services provided under this agreement, the County agrees not to discriminate against any employee or applicant for employment because of sex, age, race, religion, color, handicap, physical condition, developmental disability as defined in s.51.05(5), sexual orientation, or national origin. This provision shall include, but not be limited to the following: employment upgrading, demotion or transfer; recruitment or recruitment advertising; layoff or termination; rates of pay or other forms of compensation; and selection for training, including apprenticeship. The County further agrees to post in a conspicuous place, available for employees and applicants for employment, notices setting forth these provisions.

The disclaimer language as contained in the State Highway Maintenance Manual is included in this agreement by reference. The County is obligated to provide services under this agreement only to the extent it receives Department funding for the same. The Department recognizes that the County does not warranty that maintenance funds provided by the Department are sufficient to provide for a uniform level of service or standard of state highway maintenance applicable to all situations. 

#### RE: APPROVAL OF INTENT TO CONVEY THE PROPERTY KNOWN AS "MINDORO COUNTY PARK" TO THE TOWN OF FARMINGTON

**WHEREAS,** La Crosse County owns and maintains a 114 acre parcel of land known as "Mindoro County Park" which is a community park located one half mile west of the community of Mindoro on CTH D in the Town of Farmington; and,

**WHEREAS,** there have been discussions between the County of La Crosse and the Town of Farmington regarding the County conveying the parcel of land known as "Mindoro County Park" to the Town; and,

WHEREAS, the following conditions of transfer have been agreed to:

- 1. The County Administrator's proposed 2022 budget includes a one-time provision of \$75,000 for the purpose of improvements to the park.
- 2. Both parties are aware that the County and the parkland were the subject of federal Land and Water Conservation (LAWCON/LWCF) grant funds in the 1970s. This grant requires that the land continue to be maintained as park/recreation land accessible to the public subject to the rules and limitations of the of the grant.
- 3. Both parties are aware that any transfer of land would also need to be approved by the Wisconsin DNR as the grant manager for the Land and Water Conservation program.
- 4. La Crosse County will continue to maintain the property until such time as the property transfer ownership. At the time of transfer, all maintenance would be assumed by the new property owners.

**NOW THEREFORE BE IT RESOLVED,** that, contingent upon the Town of Farmington's acceptance and approval and approval by the Wisconsin State DNR, the La Crosse County Board hereby states its intent to convey to the Town of Farmington 114 acres of parkland currently known as "Mindoro County Park"; and

**BE IT FURTHER RESOLVED,** that the County Board Chair and County Clerk shall be authorized to execute any documents to convey such title to the Town of Farmington, approval of the conveyance and any other necessary agreements by Corporation Counsel.

**FISCAL NOTE:** The one-time \$75,000 allocation for improvements to the Park is in the proposed 2022 budget. After transfer of the park, the County will have no further financial obligation. Until transfer, cost for maintenance of the park are included in the Facilities budget.
