**CONFERENCE/MEETING REPORT** – None.

**LA CROSSE COUNTY SHERIFF'S OFFICE SUPPORT DOGS – JEFF WOLF**

Sheriff Jeff Wolf introduced the La Crosse County Sheriff's Office Support Dog Program that started in February of this year. The addition of two support dogs in the La Crosse County Jail has proven to be beneficial for assisting inmates with mental health issues. Statistics show that use of dogs in prisons and jails helps inmates emotionally and with their mental health concerns. The dogs have been received extremely well.

**RFP APPROVAL: JAIL FOOD, COMMISSARY, COMMUNICATIONS – BRYAN JOSTAD**

Bryan Jostad, Purchasing & Insurance Manager, La Crosse County Finance Department, presented. The La Crosse County Sheriff's Office has three principal service components that are outsourced and essential to managing the jail operations:

- Food and Laundry Service
- Commissary and Inmate Trust Fund
- Video Visitation, Phone Service, EMessaging

This RFP is a global view of these outsourced components. To this end, the RFP allowed vendors to provide a proposal for any one service, any combination of two components, or all three components. The contract for these services is seven years.

The timeline of the RFP is as follows:

- RFP was released on 02/18/2022.
- Vendor conference held on 03/09/2022.
- Proposals were due 04/06/2022 and reviewed by an evaluation team.
- Five vendors advanced on 04/11/2022 for interviews.

- Evaluation team met after conclusion of interviews for review and evaluation of proposals.

Based on the evaluation scores, the evaluation team recommends:

- Aramark – Food Service and Laundry
- Aramark – Commissary and Inmate Trust Fund
- Securus – Phone and Video Visitation

Discussion followed.

### **ANNOUNCEMENT OF THE VICE CHAIR**

### **ESTABLISH COMMITTEE MEETING TIME**

The committee discussed setting the meeting time for the Judiciary and Law Committee for the 2022-2024 term.

### **DISTRICT ATTORNEY ANNUAL REPORT – TIM GRUENKE**

Jessica Skemp, Deputy District Attorney for La Crosse County, highlighted the 2021 Annual Report on behalf of District Attorney Tim Gruenke as follows:

- Additional staff member approved (legal secretary) and added to “Sensitive Crimes Unit”. Position started in January.
- Currently has been operating at ten attorneys for approximately 18 months.
- State of Wisconsin does case load analysis every year. Even with the ten attorneys, the DA’s Office is still operating at 77% of what would be required for full staff of current case load.
- County Board authorized payment of bar dues for staff. Starting July, attorneys will have the bar dues paid, which is greatly appreciated.
- Total Cases Referred for Charges:
  - 2019 – Approximately 2,500 felonies / 6,500 misdemeanors
  - 2020 – Approximately 2,900 felonies / 7,200 misdemeanors
  - 2021 – Approximately 3,000 felonies / 7,200 misdemeanors
- Increase in gun-related crimes over the last three years involving felon in possession of firearm.
  - 2019 – 27 cases
  - 2020 – 47 cases
  - 2021 – 58 cases

Discussion followed.

### **CLERK OF COURTS ANNUAL REPORT – KELLY GOYETTE**

Kelly Goyette highlighted the 2021 Annual Report for the Clerk of Courts Office:

- Currently have five seated judges.
- Many retirements in the Clerk of Courts Office. Slowly filling those positions. Will be back to full staff soon.
- In custody and intake court still happening via Zoom. Process has been working smoothly.
- Courtrooms are open.
- All five courtrooms have been fully outfitted with plexiglass for jury trials.
- Case load has remained steady for the past three years. There had been a decline in small claims filings due to the eviction moratorium related to Covid.
- Goals for 2022:

- Continue to send debt collections to State.
- Get staff up full and running.

Discussion followed.

### **MEDICAL EXAMINER ANNUAL REPORT – TIM CAND AHL**

Tim Candahl, Medical Examiner for La Crosse County introduced Deputy Medical Examiner Beth Lubinski and presented their 2021 annual report.

#### **Department Overview:**

- Investigate all deaths that occur outside a medical facility.
- Investigate all deaths that occur within 24 hours of hospital admission.
- Investigate all deaths where the decedent has had a fall in the six months preceding death.
- Verify identity of decedents prior to cremation.
- Signing of cremation permit after decedent identity is verified.
- Transport decedents for autopsy and obtaining bodily fluid samples for toxicological investigation.

#### **2021 Highlights:**

- Initial increase in Covid-19 cases to start the year, steadily decreasing toward the end of 2021.
- Significant increase in workload due to rise in overdose cases.
- Increased strain on office staff due to insufficient staffing/increased call volume.
  - Hired a full time Administrative Clerk and Full Time Deputy Medical Examiner to compensate for increased workload.

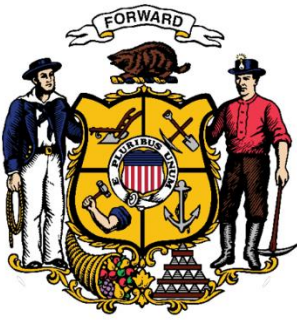

### **Re: 2021 Annual Inspection**

Dear Sheriff Wolf:

On October 27, 2021, the annual inspection of the La Crosse County Jail was conducted pursuant to WI Statute 301.37(3). The inspection compared the facility and its operation to applicable state statutes and Department of Corrections Administrative Code Chapter DOC 350. This inspection consisted of a tour of the facility; interviews with administration, staff and inmates; review of inmate files; and a review of facility records and documentation.

### **Changes Since Previous Inspection**

- Implemented the Guard 1 system to replace the Pipe system.
- Implemented a new key exchange procedure along with reducing the number of keys that staff carry.
- Implemented a new live scan fingerprint machine into the booking area.
- Allowed more program providers back into the jail to offer more programming opportunities.

### **Goals and Initiatives**

- Coordinate Sergeant meetings every 6 weeks in order to discuss operational and managerial topics.
- Facilitate weekly staffing meetings with staff.
- Cross train sergeant at different positions.
- Implement taking palm prints and sending mug shots to CIB.



## **Summary of Jail Operations**

I met with the administrative, security, healthcare, and foodservice staff to conduct the annual inspection. The inspection included a review of records and practices, as well as a walkthrough of the detention area to assess the safety, sanitation, adequacy, and fitness of the facility. My observations during the inspection revealed cordial and professional interactions between the staff and persons in custody. Captain Verse and his staff are to be commended for the positive feedback and facility climate.

The maximum rated capacity of the facility is 274. On the day of the inspection, there were 86 inmates incarcerated in the facility. The La Crosse County Jail is approved for double celling per DOC 350.20 and is not approved to house juveniles.

## **Variances**

- The La Crosse County Jail has six variances on file with the Department.

## **Inspection Findings**

- There were no violations noted during this year's inspection.

## **Approval**

The La Crosse County Jail is approved by the Department of Corrections for the secure detention of adult inmates with the maximum capacity of 274.

I wish to thank Captain Verse and his staff for their assistance, cooperation and professionalism during the inspection process.



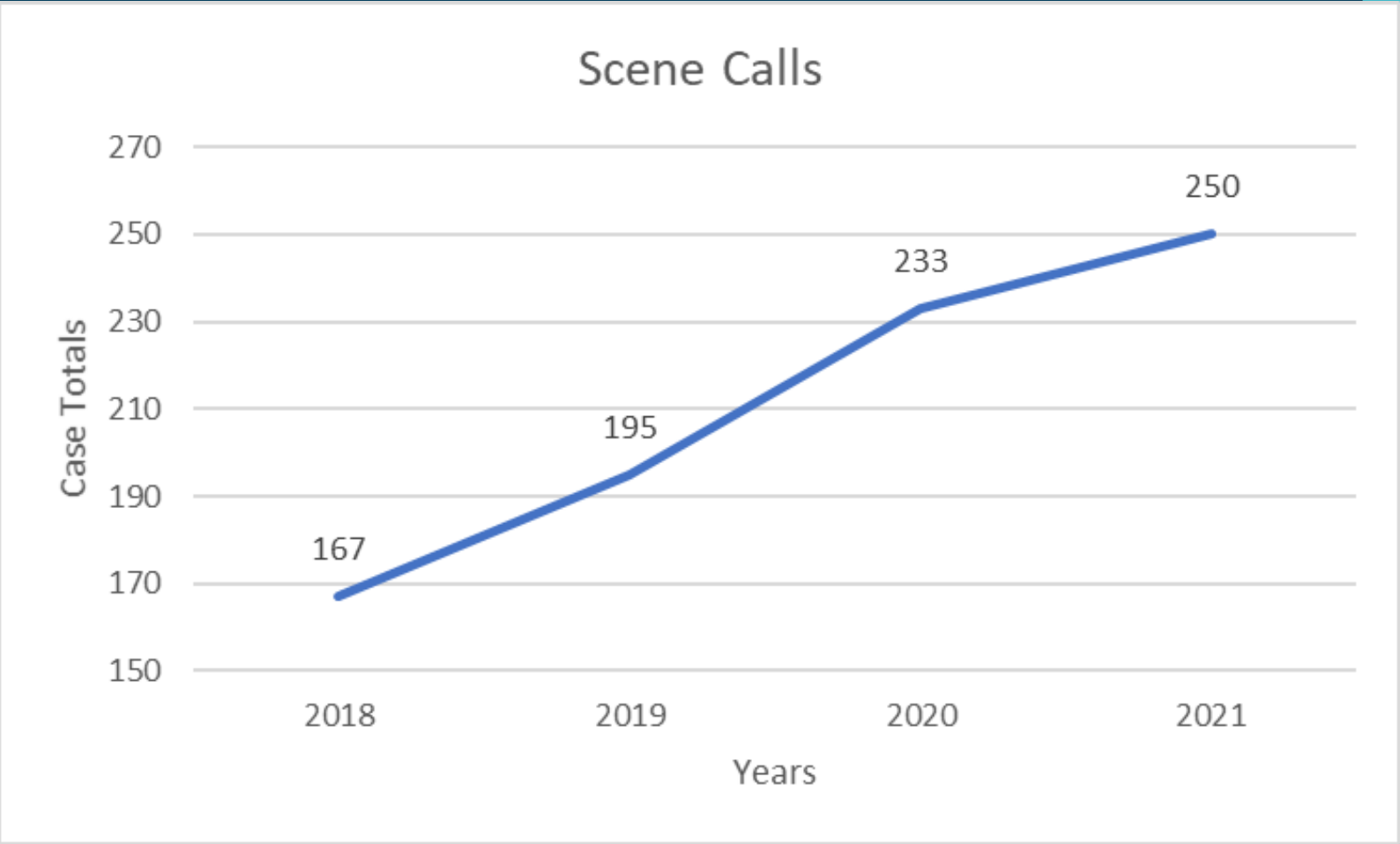

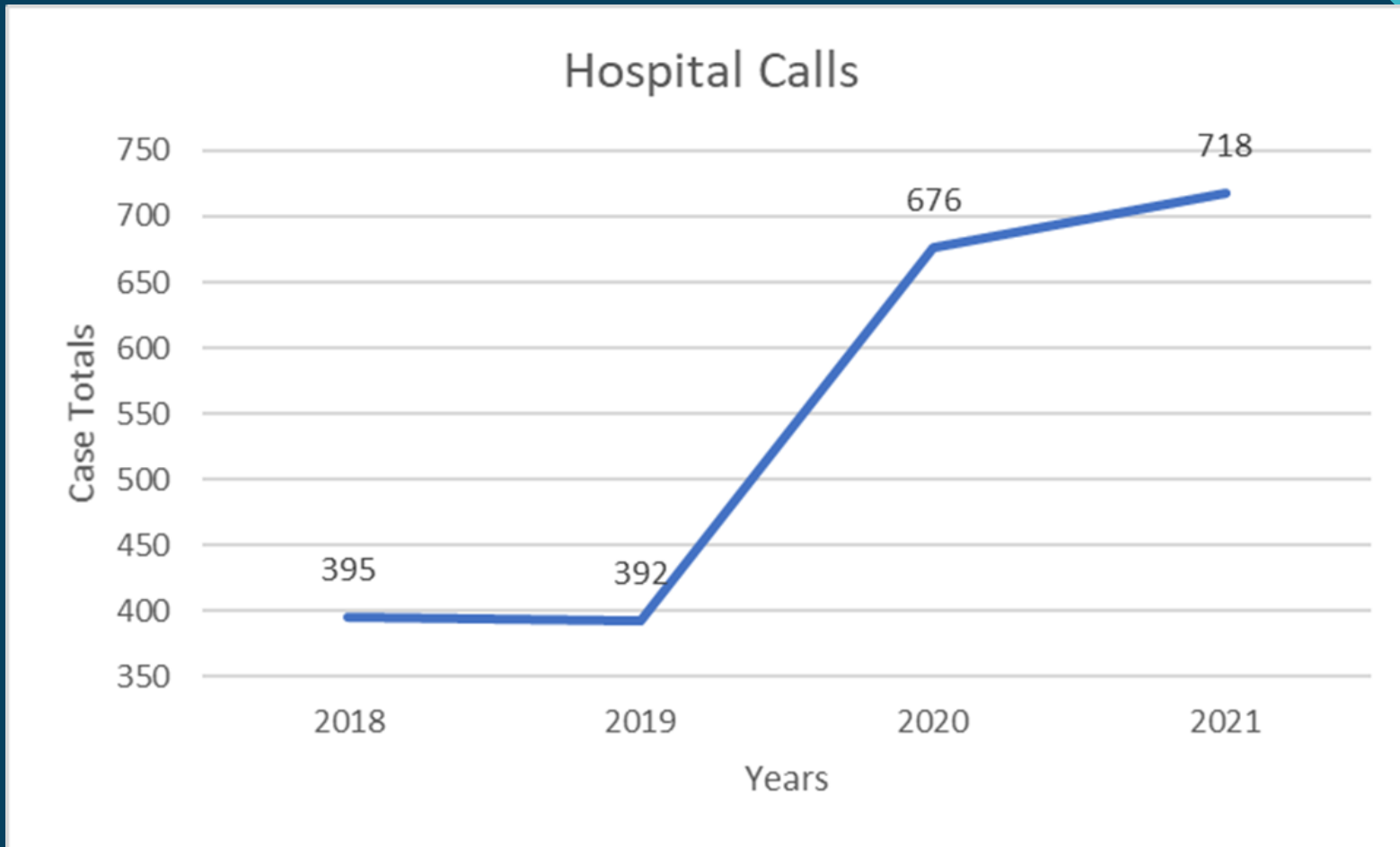

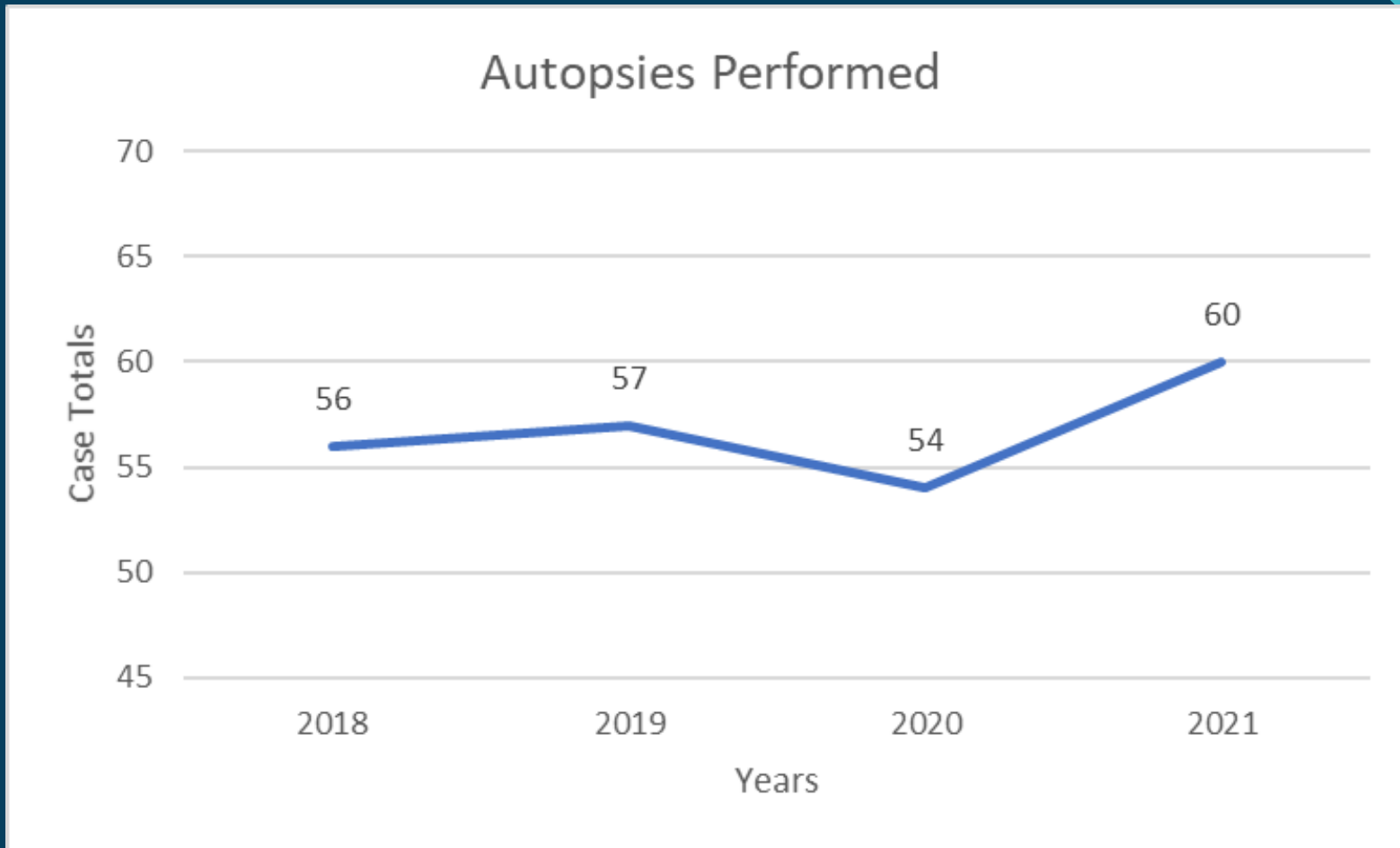

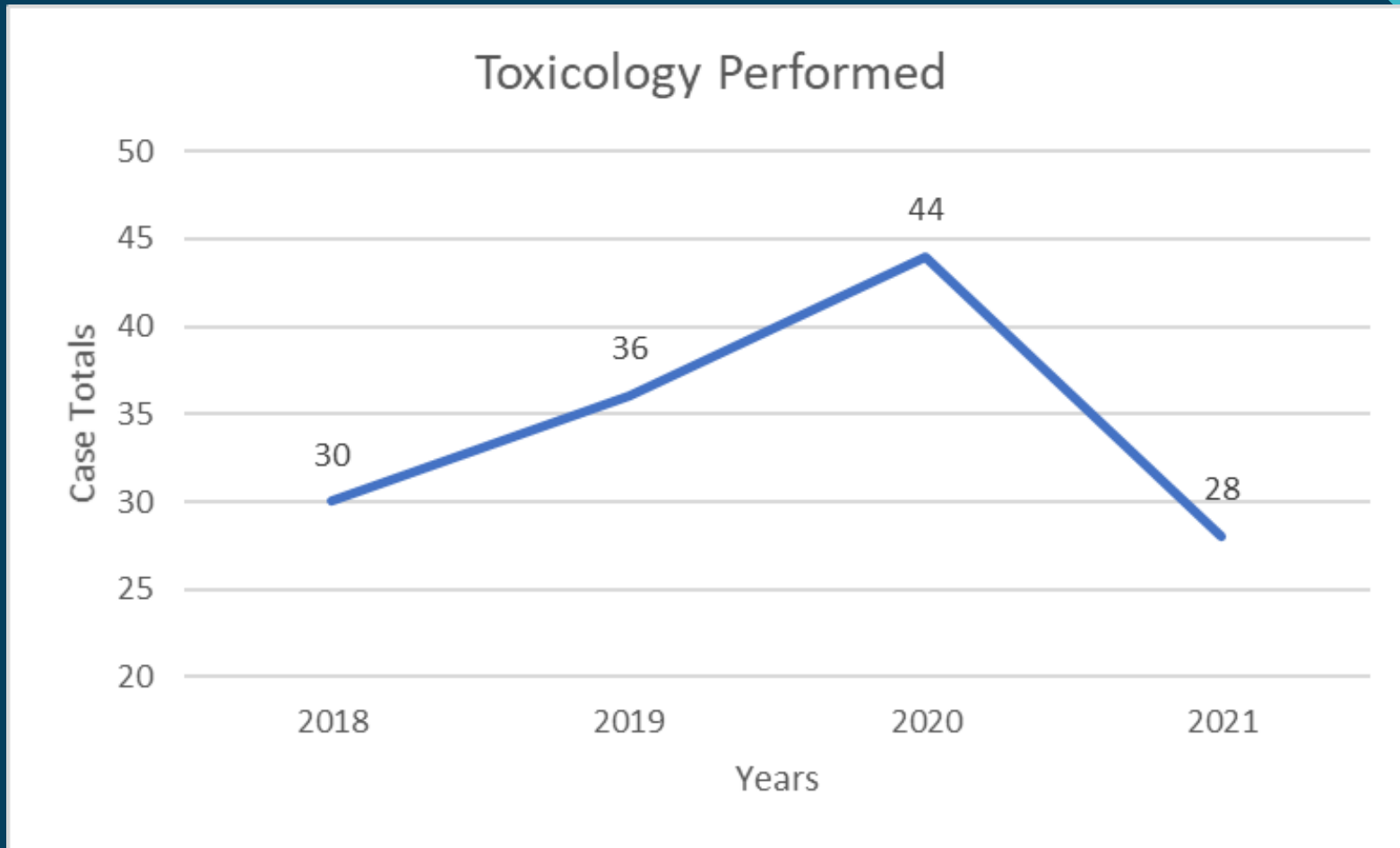

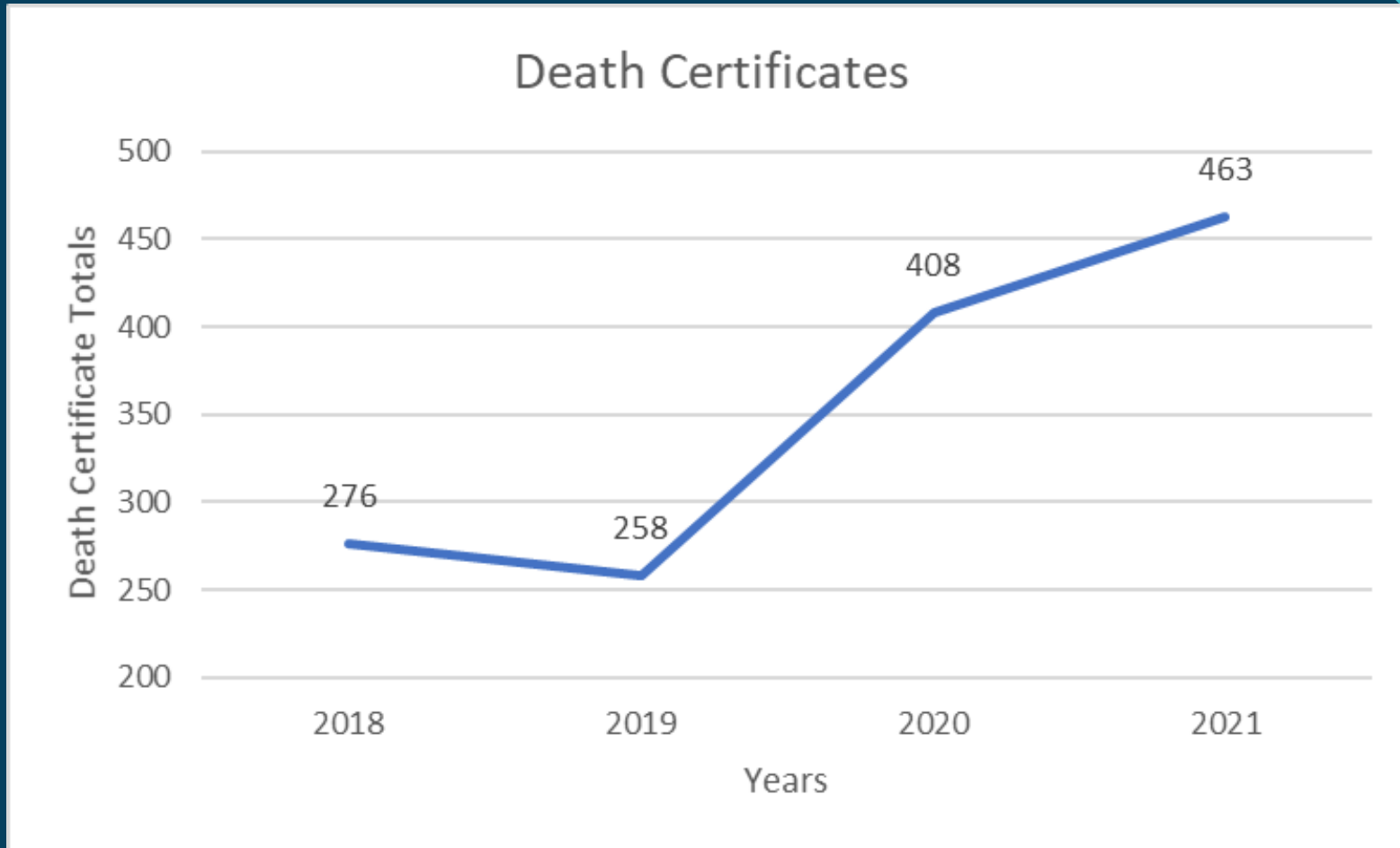

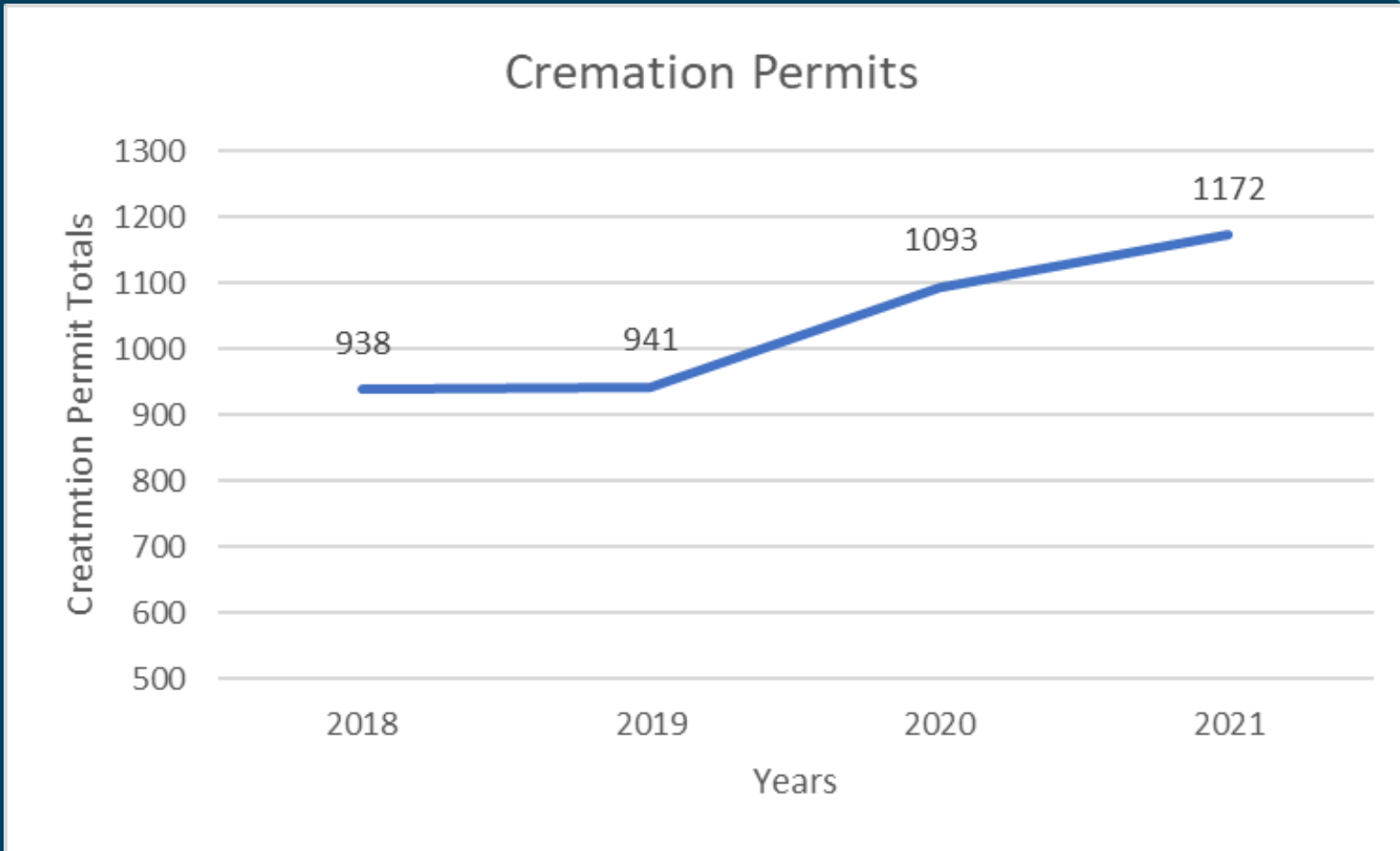

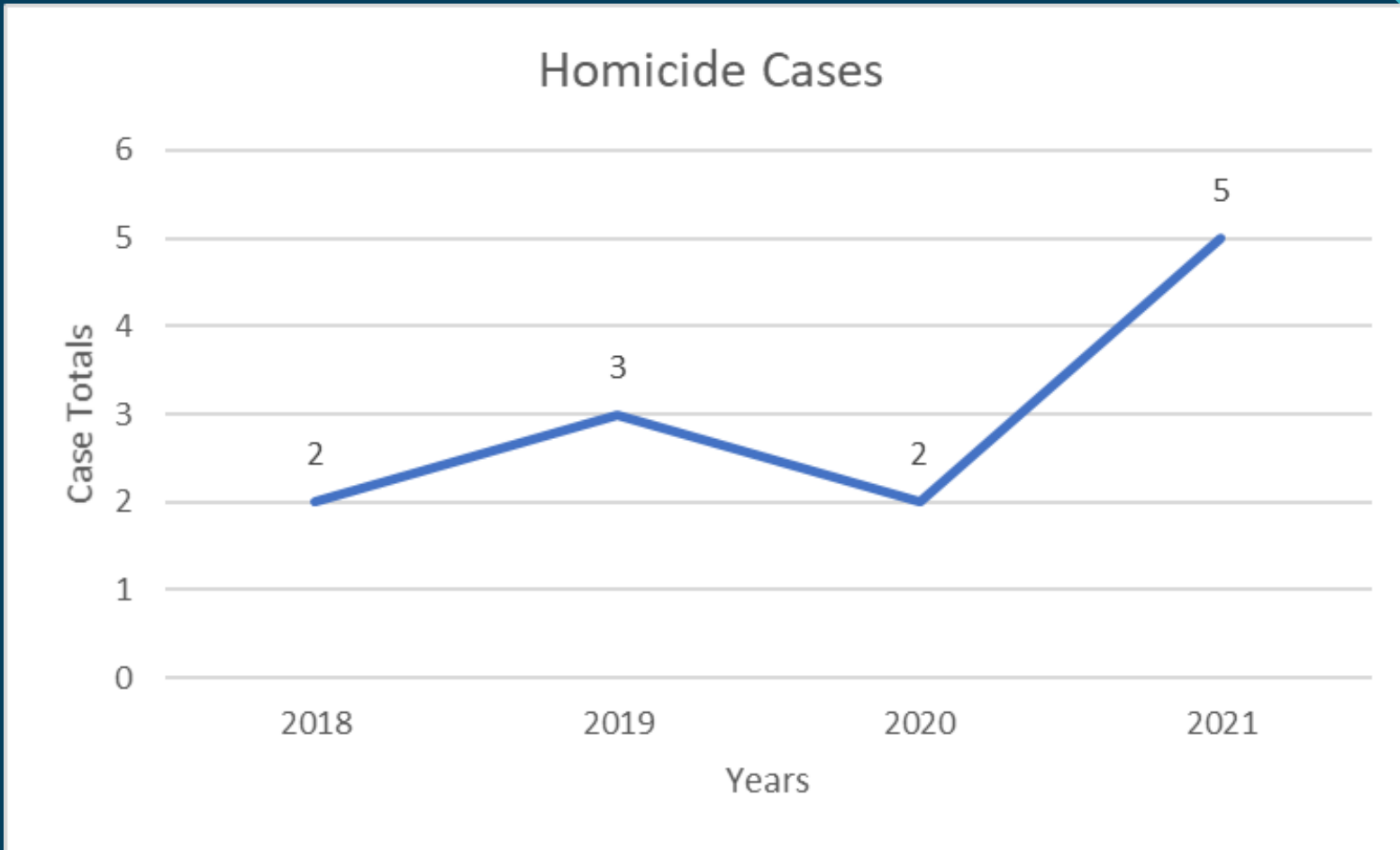

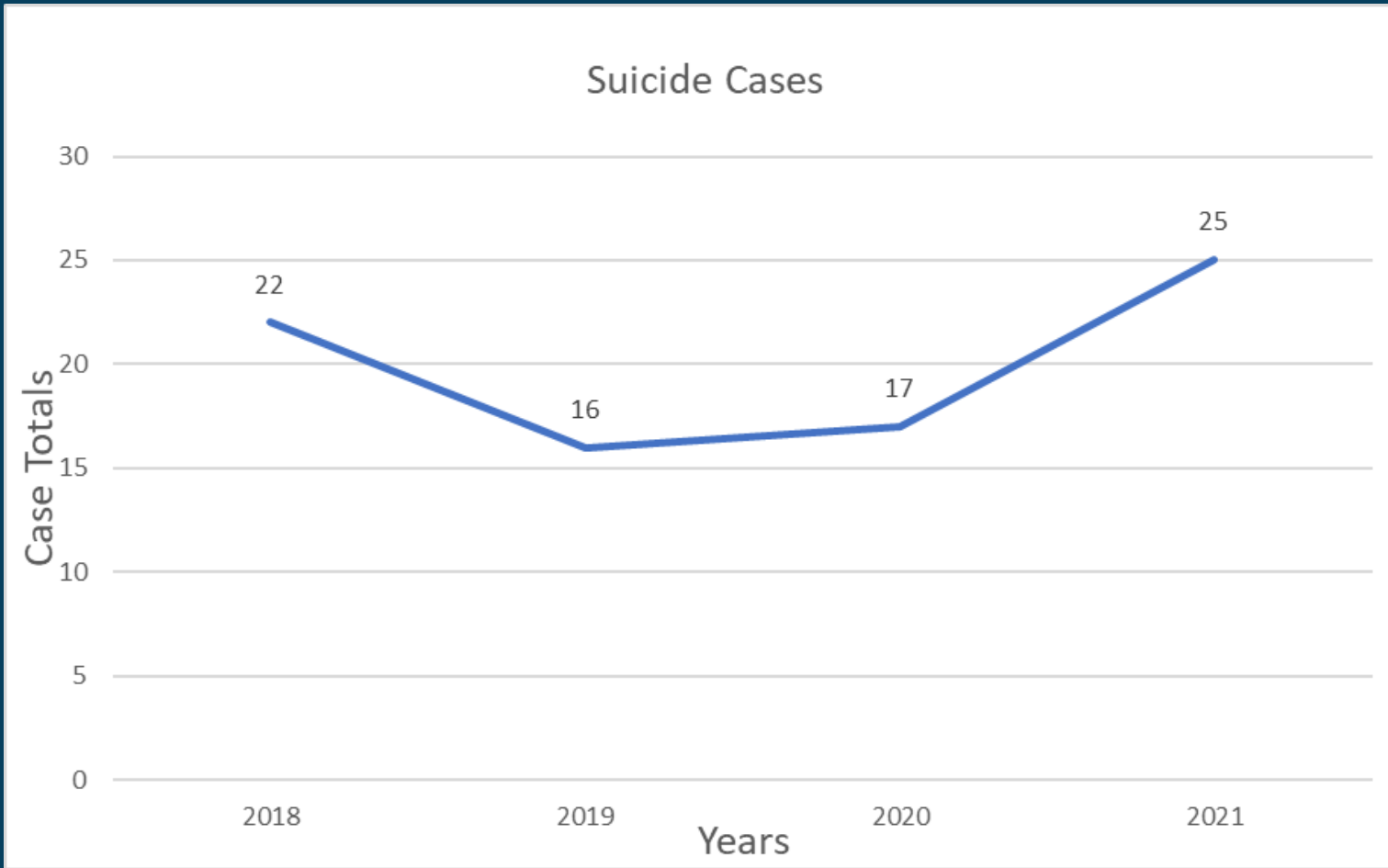

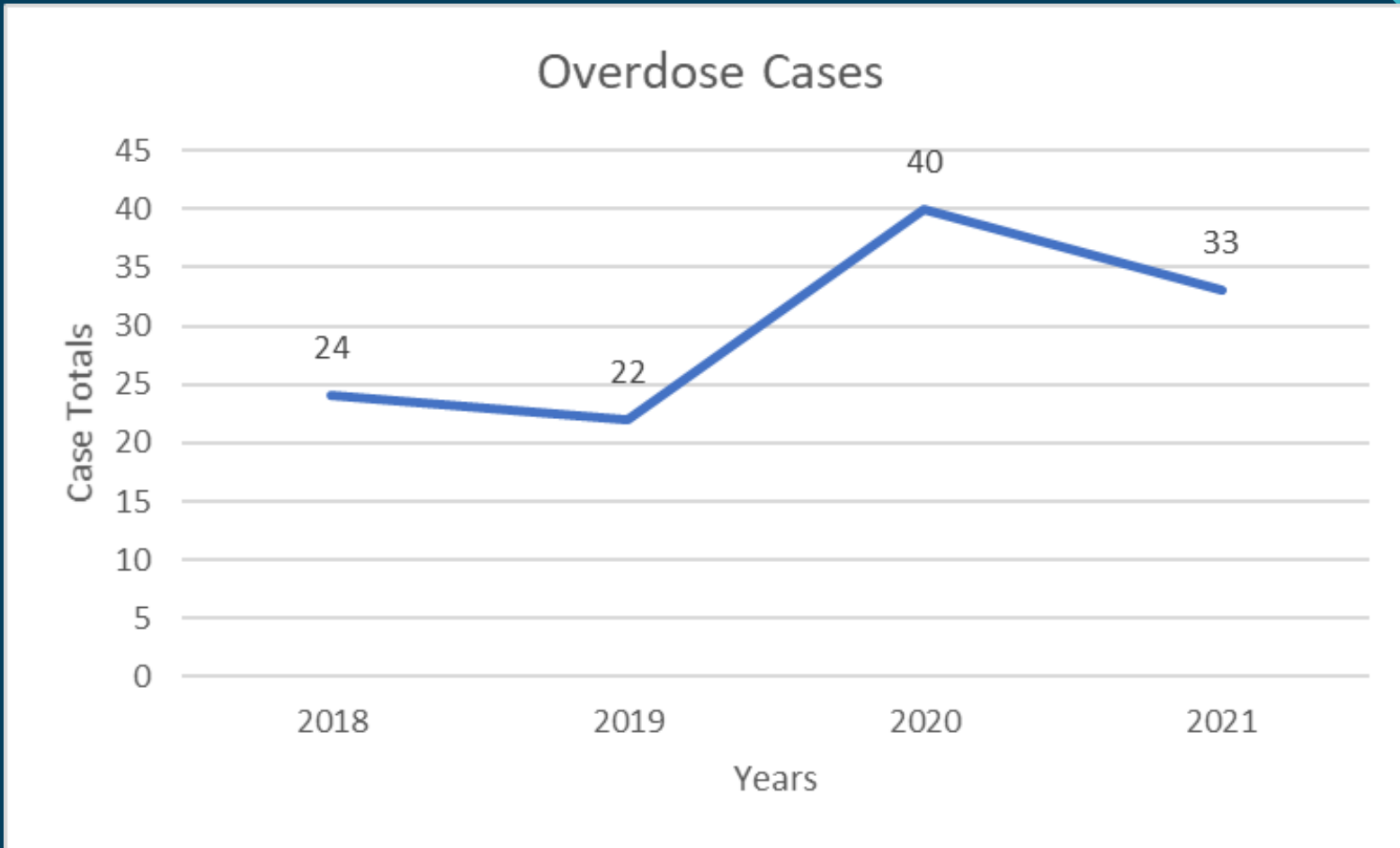

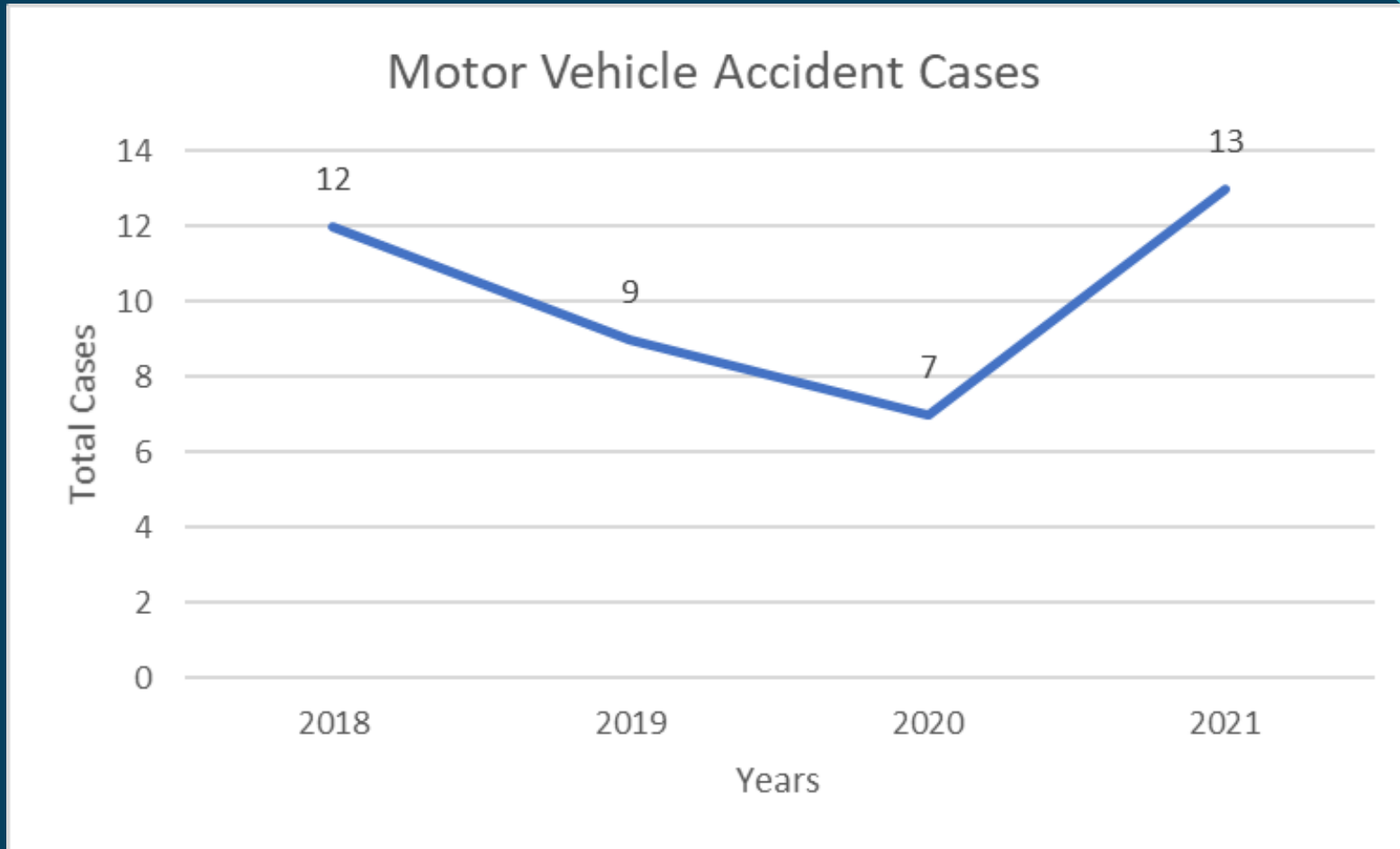

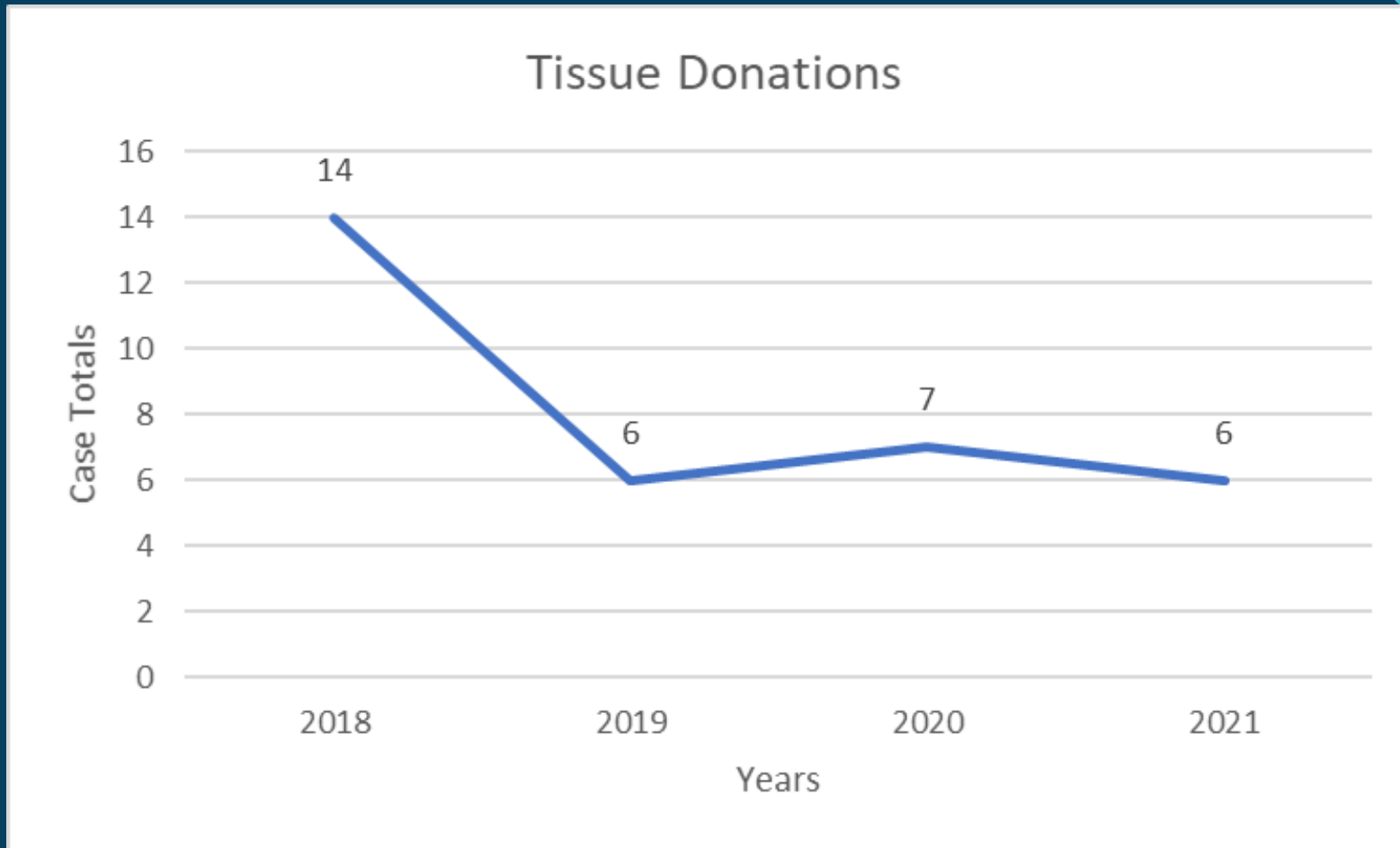

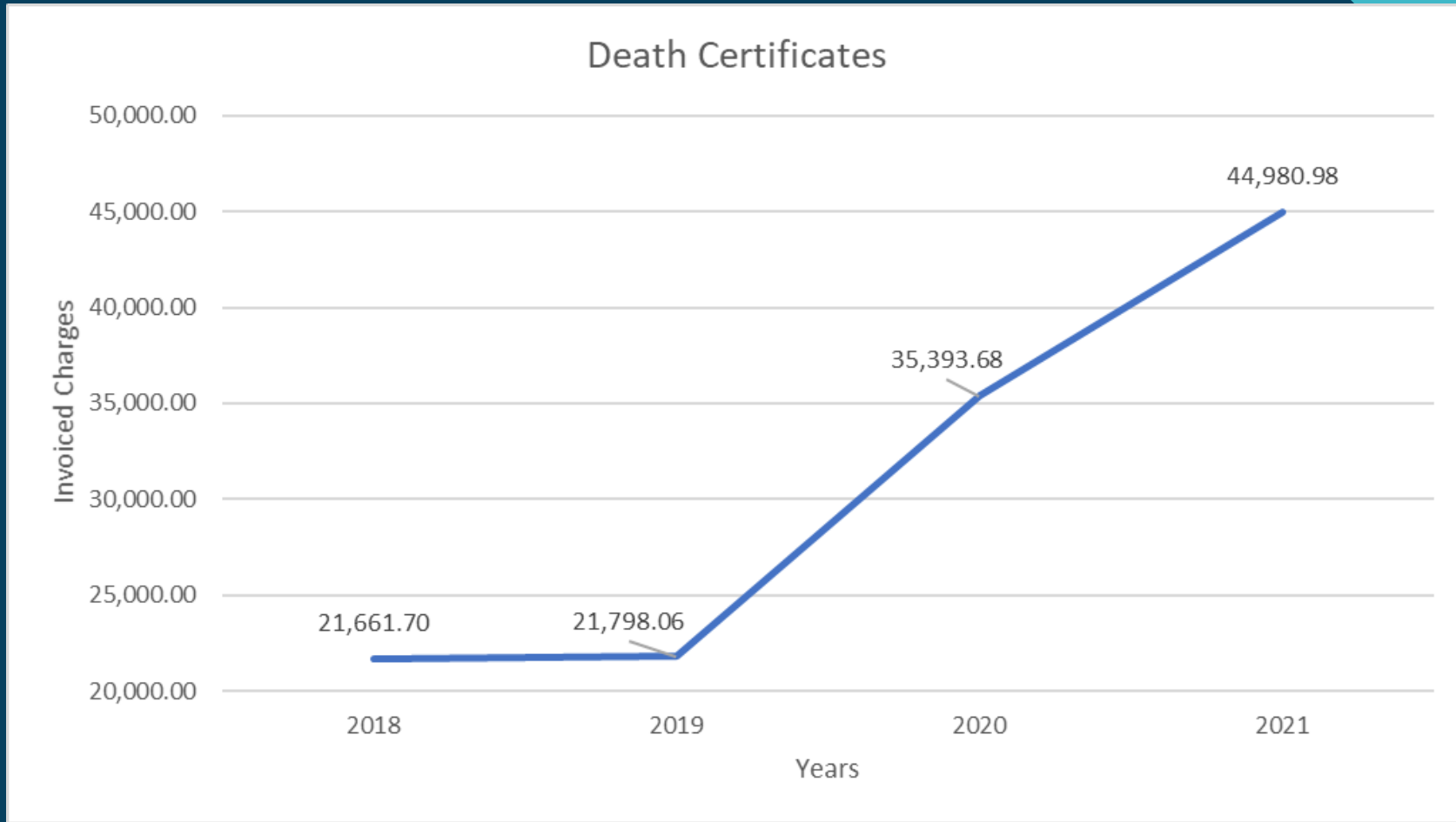

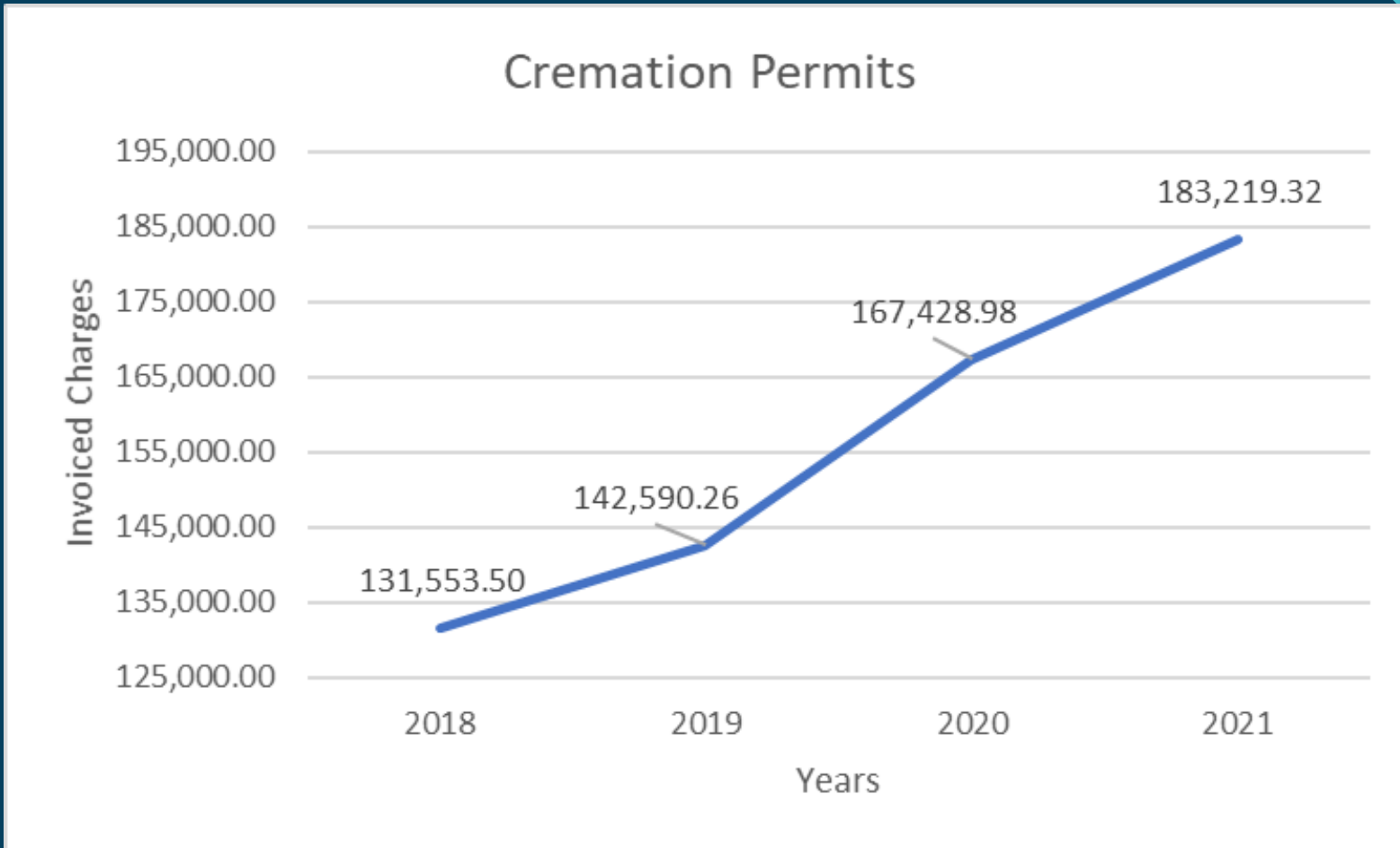

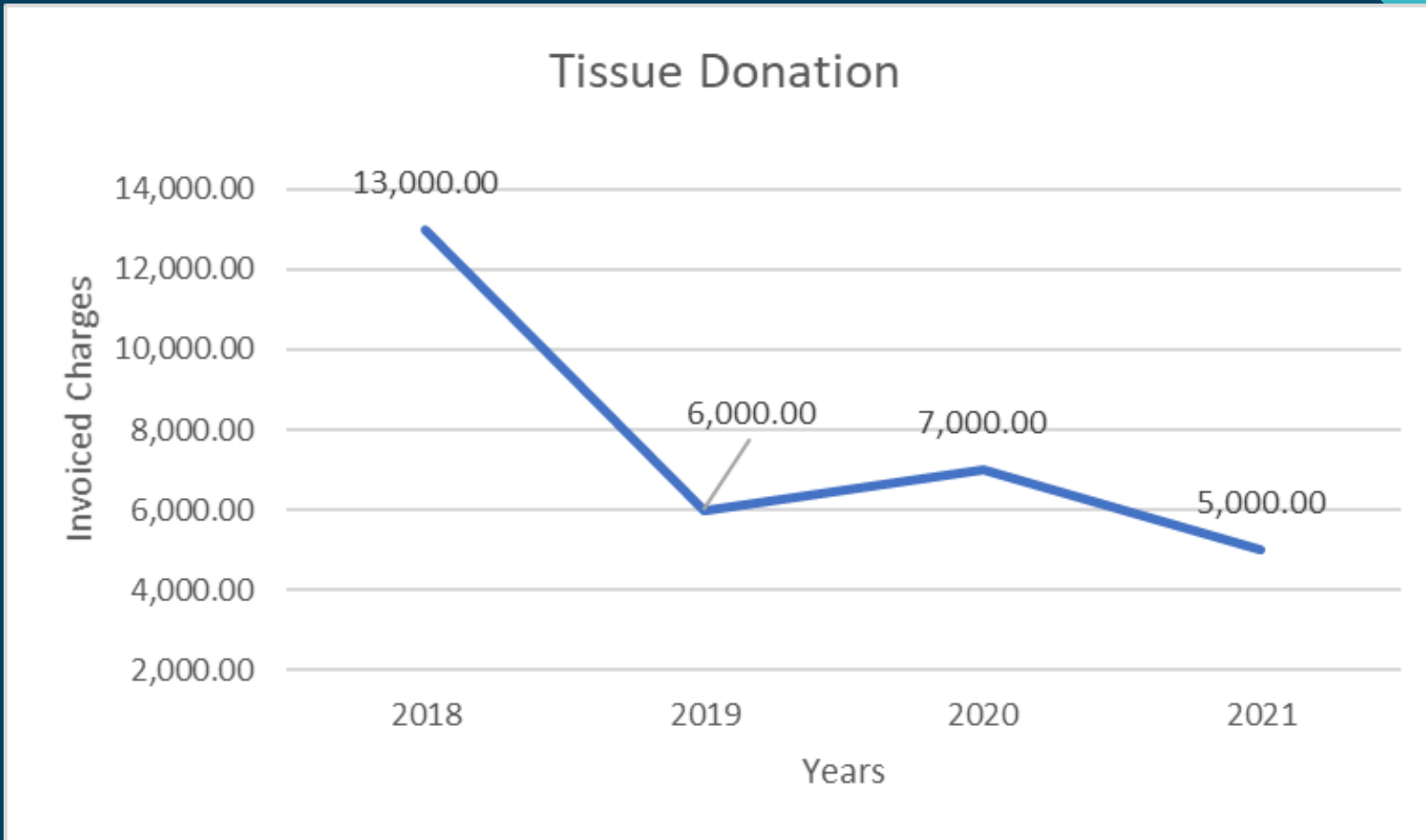

# Looking Forward

- COVID cases have decreased significantly
- Currently in the process of hiring more Part Time Deputy Medical Examiners to help cover the increasing workload
- To better serve the public, we are arranging times to meet with area agencies to discuss procedures and protocols
