#### CONSENT AGENDA:

An updated consent agenda was distributed to members. Director Plachecki reviewed the information provided in the packet. Staffing continues to be a significant challenge at both Hillview and Lakeview Campuses. They currently have vacancies on the day shift which are a rare occurrence. Over 160 people have left employment over the last 12 months. A talent acquisition recruiter has been hired to do some outreach. Beds at Hillview have been lowered to 85.

### CONFERENCE/MEETING REPORT: None.

#### Announcement of Vice Chair:

Chair Plesha announced that Grant Mathu will serve as the Vice Chair.

### Date and Time of Meeting:

Motion by Ferries/Padesky to continue to hold the meetings on Monday of Committee Week at 8am. **Motion carried unanimously.** 

### Veterans Services Update:

Veterans Service Officer Adam Flood gave an update on his office and what they have accomplished in the last couple of months. Communications and feedback show customers are 90% satisfied. They will be using the website to identify where the Veterans Service Coordinator will be located in the public for outreach. The coordinator is identifying key areas including REACH Center and Libraries and posting updates on a monthly basis. They continue to look into services on what they can do to improve their services.

### HILLVIEW PLANNING and DESIGN UPDATE:

Representatives from Hoffman, Jon Rynish, Jason Diem, and Julie Heiberger were present to provide an update on the plan. The project will include 48 CBRF beds that will divided to include a 16 bed high acuity wing, a 16 bed memory care wing, and 2 smaller wings with 8 beds for individuals with dementia and behavior symptoms. Hoffman is about 1/3 of the way through the design process right now. The budget for this project is \$11.5 million. Renderings of the site were shared. They will continue to watch pricing of supplies as the project moves forward. It was also noted that there is a known archeological site on this property and the DNR will need to be contacted to see what this will require.

## STAFFING UPDATE:

Staffing challenges continue at both campuses with our Talent Acquisition Recruiter and hiring managers working hard to recruit and fill open positions. Both the Hillview and Lakeview campuses have enrolled as providers in the Wiscaregivers Career program which will pay for C.N.A. training and provide a 6-month retention bonus to individuals employed by participating providers. Our Talent Acquisition Recruiter is working with the marketing team to develop promotional materials for this program. Both campuses are also working with the local high schools in the Health Science Academy and Youth Apprenticeship programs to encourage students to work in health care and become C.N.A.'s. Four students from area high schools will be working in our system as they gain high school credit and valuable work experience in this field.
