CALL TO ORDER

Chair Tim Gruenke called the meeting to order at 5:02 p.m.

APPROVAL of July 16, 2025 MINUTES OF THE CRIMINAL JUSTICE MANAGEMENT COUNCIL:

MOTION by ((Wacek/Larson)) to approve the July 16, 2025 minutes of the Criminal Justice Management Council.

Motion carried unanimously: Veerasamy, Siegal, Stratman, Schott, Teff, Sersch excused.

Reentry Panel Presentation: A guest panel with representatives from Justice Support Services (Cyndi Gorsett, Marissa Miller, and Jodie Muth); Project PROVEN from Western Technical College (Jai Mather, Colin Walsh), and Department of Corrections (Paul Miller and Carissa Meyer) addressed questions developed by the CJMC committee members to help get a better understanding and perspective of needs, barriers and successes from those who are engaged with individuals who are formerly incarcerated in the county jail or prison. Panelists shared perspectives on the barriers faced by individuals returning to the community after incarceration, highlighting housing, employment, stigma, and strained family and peer relationships as major challenges. They noted limited access to detox, crisis stabilization, and longer-term treatment, with long waitlists and distance from family supports compounding the problem. Individuals with significant mental health needs often struggle to access or maintain services, and many remain in jail while awaiting appropriate placement.

Panelists emphasized that success in reentry depends on consistent relationships, trust-building, and coordinated support, rather than short-term compliance measures. They identified gaps created by duplication of services and reliance on temporary grant funding, along with community resistance to housing options despite their lower cost than incarceration. Suggestions included improving system coordination, expanding supportive housing, and increasing public education to shift perceptions away from fear and stigma. Overall, panelists underscored the importance of sustained, long-term person-centered support and a welcoming community environment to help reduce recidivism and promote stability.

The La Crosse County Criminal Justice Management Council (CJMC) endorses the grant application being submitted by Justice Support Services for TAD Funding for 2026. We support the application for continued baseline funding, as requested.

The La Crosse CJMC is comprised of members from the County Administrator's Office, Circuit Court Judges, community members, County Board of Supervisors, the CJMC Coordinator (the JSS Manager), the District Court Administrator, the District Attorney's Office, the La Crosse Police Department, the La Crosse County Sheriff's Department. The State Public Defender/Local Criminal Defense Bar, victim services providers and the Wisconsin Department of Corrections. The CJMC meets monthly and provides oversight to many areas of practice in La Crosse County's criminal justice system.

Over the last two decades La Crosse County has successfully implemented bail monitoring, gender-specific programming and multiple treatment courts to reduce the jail population and recidivism. TAD funding has assisted in implementing a comprehensive pretrial system as well as enhancing our pre and post charge diversion programs. This is done with the support of the CJMC and with several members directly collaborating with our diversion programs.
