## To report errors

The Institute for Safe Medication Practices (ISMP) has a website to report vaccine errors—the Vaccine Error Reporting Program (VERP). VERP was created to allow healthcare professionals and patients to report vaccine errors confidentially. By collecting and quantifying information about these errors, ISMP will be better able to advocate for changes in vaccine names, labeling, or other appropriate modifications that could reduce the likelihood of vaccine errors in the future. http://verp.ismp.org

CDC recommends that healthcare professionals also report vaccine errors to the Vaccine Adverse Events Reporting System (VAERS). If an adverse event occurs following a vaccine administration error, a report should definitely be sent to VAERS. Adverse events should be reported to VAERS regardless of whether a healthcare professional thinks its related to the vaccine or not, as long as it follows administering a dose of vaccine. https://vaers.hhs.gov/index
