

HHS Board Update: Tina Tryggestad – no updates currently.

**HS Director Update:** Jason Witt – Jason will present on the different things Human Services and their programs have done during this difficult time at the County Board Planning Meeting on Monday February 8<sup>th</sup>. If you are interested in hearing his presentation you may attend.

**HS Service Section Update** – Mandy Bisek (Manager of Justice Support Services) shared with the group that they have a unique opportunity available through the State of Wisconsin, Department of Children and Families, which is a service called "Runaway and Homeless Youth (RHY). With this service we will be collaborating with many of our community partners. Once we receive the paperwork it will go through the board for a resolution. More information to come about this service.

- Wisconsin Association of Family & Children's Agencies (WAFCA) is the united voice for more than fifty member agencies and leaders in the human services field serving more than 250,000 individuals and families throughout Wisconsin.
  - 2021 Legislative & Biennial Budget Priorities
    - Putting Family First
      - o Invest in home visiting expansion and early care and education opportunities
      - o Advance access to evidence-based services
      - Support increases in kinship care and foster care rates
      - Support foster youth transition to adulthood
      - Return 17-year-olds to the youth justice system
    - Moving Forward on Mental Health
      - Support Medicaid expansion to extend coverage and access for individuals up to 138% of FPL
      - o Target additional mental health resources to support students and school staff
      - o Support initiatives to remove mental health service access barriers
      - Increase Medicaid day treatment rates to recover from stagnant rates & to adjust for recent changes to day treatment rules
      - o Support an increase in the clinical supervision grant program
      - Support expanded staff capacity & technology investments
    - Adopting Regulatory Reforms for Streamlined Services
      - o Improve training tools and safety in youth congregate care settings
      - Adopt liability reforms for private child placing agencies, GH & RCC's to reduce risk exposure & enable more providers to care for youth
      - Require DHS & DCF to recognize national accreditation when renewing out of home care licenses & clinic licenses

Jason shared with the group the current timeline:

- January-March is for us to <u>learn</u> about policy priorities of advocacy and different organizations with connections to Family Policy Board.
  - The following will be shared with the group in these three months:
    - Wisconsin Counties Association (WCA) was shared in January
    - Wisconsin Community Action Program Association (WISCAP) was shared in January
    - Wisconsin Association of Family & Children's Agencies (WAFCA) was shared this month (February)
      - Early Childhood Advisory Council (ECAC) will be sharing with us in March
- April is for us to discuss and finalize priorities & advocacy strategies. We will continue small group discussions.
- May/June is for us to <u>advocate</u>
  - Bi-annual legislative meeting (May)
  - Letter to JFC
  - o Other?

- c. Housing needs to be dealt with before most other needs. We would suggest advocating especially for the State to make sure COVID resources that are not being used for other issues be directed there (we had heard that the State's federal dollars for COVID are not all being spent).
- d. Wellness for youth in our communities
- e. Return of 17-year old Youth to YJ system
- 2. What other issues that were not discussed today would you like to see prioritized?
  - a. Remove barriers to accessing mental health system
- 3. Are there a slate of issues from an advocacy organization you are connected with that you would like to present during a future month's Family Policy Board meeting?
