REGULATED ROADS

This parade permit is being issued by La Crosse County pursuant to S.349.185 Wis. Stats. which authorizes the authority in charge of the maintenance of a highway to regulate certain events on that highway by order, ordinance or resolution. La Crosse County ordinance s.13.04 regulates the use of highways within its jurisdiction for parades, runs, walks, etc.

Please be aware that our permit does not authorize this usage on City, Village or Town roads **IF** the municipality has regulations established by order, ordinance or resolution. Therefore, if your event utilizes a City, Village or Town street or road for any portion of the event, you will also have to comply with any applicable Municipal regulations.

As part of our permit process, the appropriate City Clerks, Village Presidents and Town Chairpersons are notified of your event and are provided with a copy of your permit application and map.
