What is Clinical Supervision & Consultation?

In the field of mental health social workers, counselors, and practitioners are all engaged in our "practice". That is to say we all have unique skills and knowledge, but are constantly on a journey of learning more, getting better at what we do, and adapting to changes. Ethically, we have the responsibility to ensure best practices to those we serve by consulting with others, to improve our knowledge base, and to share our knowledge and experience (COOD of Ethics: ACA C.2.0, NASW 2.05).

Clinical supervision goes beyond being told what to do. Clinical supervisors function in part as teachers, counselors, and consultants. As teachers, they teach new skills, how to apply interventions, and expand professional knowledge base. As coaches/counselors, they help to promote an individual's self-growth, positive esteem, reflect on their own transference needs, and provide a place to process emotions to reduce burn-out. As consultants, they help provide alternative ways to view client situations and bridge the gap between clients' needs, system requirements, and ethical decision making.

Within the CCS program, clinical supervision or peer collaboration is required of every practitioner, regardless of credential, in order to promote best practices and supports to consumers. For those who are not licensed medical or mental health providers, the expectation is for every 30 hours of face-to-face service a staff will engage in 1 hour of clinical supervision with a licensed practitioner. For those who are licensed medical or mental health providers, the expectation is for every 120 hours of face-to-face direct service or clinical supervision provided the provider will engage in 1 hour of peer consultation or collaboration. DHS will accept clinical supervision/peer consultation that occurs in individual sessions, group meetings, or in a side-by-side session with a consumer. The preference for supervision is to be done in a face-to-face setting, but is also allowed to be done via approved telehealth systems. At this time WI-DHS only recognizes telehealth systems PolyCom and Microsoft Lync/Business Skype as valid teleconferencing options for clinical supervision.



Vendors that have recently added Service Planning and or had a rate increase. Please note that our QA staff are working very diligently to update all of the service authorizations. Billing CCS Time to Medicaid

As of June 1st, WRIC-CCS is fully implementing the Medicaid requirement that "Documentation should include the specific service delivery time and the specific time period spent documenting the service...including all service delivery and documentation time provided in a residential setting", and for travel "the time and distance traveled in miles must be documented in the member's medical record." Medicaid CCS Billing & Claims Manual topic #17219

As some providers and county staff have begun trying to break old billing habits, some lessons have been learned:

- 1. There are many different ways to <u>personally track specific start & stop times prior to writing out your progress notes</u>.

 Try out methods that makes the most sense to you personally and/or consult with colleagues to brain storm different ideas.
- The absolute <u>minimum time</u> requirement for a billable service is <u>8 minutes</u>.
 8+ minutes of round-trip travel. 8+ minutes of combined face-to-face and documentation time.
- 3. New math method: <u>add up total minutes before rounding to units</u>. Historically we have rounded to units first then added up total units of services. Make sure to add minutes before rounding. This more accurately reflects and gives credit to your total time.

Face-to-Face 42 mins = 3 units Documentation 8 mins = + 1 unit Total Direct Service = 4 units Face-to-Face 50 mins = 3 units Documentation 20 mins = + 1 unit
