**CCS UTILIZES WRAPAROUND TEAMS**

A team is formed for each CCS Consumer that includes: the consumer, service facilitator, mental health professional, service providers and other individuals (family, friends, etc.) that the consumer (you) wishes to include for advocacy and support. **This team meets at least monthly to ensure success.**

**Coordinated Services Team  
(CST)**

CST is...

- A Wraparound team process that is strength based and driven by a shared set of core values (family centered, outcome oriented, strength based, culturally responsive, community based, individualized planning, builds on natural supports).
- Provides families access to needed support and services as well as ownership of their own plan.
- Team approach to respond to consumers with multiple needs.
- Services are supported through collaborative efforts of both formal and informal supports.

## CCS COST TO YOU

CCS IS A VOLUNTARY PROGRAM THAT IS PRIMARILY FUNDED BY MEDICAID. IF YOU ARE PARTICIPATING IN CCS AND ARE NO LONGER COVERED BY MEDICAID, THERE WILL BE COST TO YOU FOR SERVICE

## CCS CORE VALUES

- YOU ARE THE DRIVER AND WILL BE PART OF A TEAM
- BUILDS ON NATURAL & COMMUNITY SUPPORTS
- GOAL DRIVEN/OUTCOME ORIENTED
- SERVICE ARE BASED ON CLINICAL NEED
- SERVICE PROVIDED AT LOCATION OF CLINICAL NEED
- SERVICE WILL BE PROVIDED IN THE LEAST RESTRICTIVE MANNER
- CCS STRIVES TO PROVIDE SERVICES IN COMMUNITY SETTINGS
- CCS WILL WORK WITH INDIVIDUALS TO EMPOWER AND PROMOTE INDEPENDENCE

## WHAT THE CCS PROGRAM CANNOT PROVIDE

- Respite or child care
- Transportation
- Autism, developmental disability, and learning disorder services
- Crisis Intervention
- Youth Residential and Placement Service
- Services that are not rehabilitative, including services that are primarily recreation-oriented

CCS is a Service Facilitation model that uses the CST philosophy designed for both children and adults with either a mental health disorder and/or a substance abuse disorder

## CCS PROGRAM SERVICES

Services provided under CCS are available to individuals on Medicaid (MA), functionally eligible, and individually determined through the assessment and the service planning process. Possible services include:

- SCREENING/ASSESSMENT
- SERVICE FACILITATION/SERVICE PLANNING
- INDIVIDUAL SKILLS DEVELOPMENT & ENHANCEMENT
- WELLNESS MANAGEMENT
- EMPLOYMENT SKILL TRAINING
- PEER SUPPORT
- SUBSTANCE USE TREATMENT
- MEDICATION MANAGEMENT
- PSYCHOTHERAPY
- PSYCHOEDUCATION
- DIAGNOSTIC EVALUATION
