HHS Board Update: Tina Tryggestad

Last month the HHS Board accepted the Wisconsin Department of Justice grant funding to support youth justice mentoring. The funding adds a third part-time Cultural Liaison, increasing service from 60-90 hours per week. This is through the System of Care which was created to address racial disproportionality in our youth justice system. The Cultural Liaisons are a collaboration with Hope Restores.

There are many new members on the County Board, some of whom are also on the HHS Board. Mike Baroni, County Board Supervisor, will be the new representative for this group.

The HHS Board consists of six County Board members and three citizen members. The State strongly suggests a physician and a nurse serving as citizen members. Recently, Dr. Laurie Logan filled the physician position, and Beth Clements is in the nurse position. One citizen member position is still open, and they are hoping to have it filled at the next meeting.
