College Students and Temporary Eligibility for Food Share	Economic Support (ES)	The Federal Department of Education started sending emails to college students with expected family contributions of \$0 on March 31, 2021. The email notifies students of their temporary eligibility for Food Share due to the covid-19 pandemic. As part of the covid-19 relief bill passed in December 2020, students enrolled at least half-time in an institution of higher learning, who are either eligible for state or federal work study or have an expected family contributions of \$0, are temporarily eligible for Food Share. Under normal Food Share rules, most college students are not eligible for Food Share. As a result of the efforts by the Department of Education, Consortia are preparing to receive an increase in Food Share applications from college students. Collaborative and Creative Positions	JSS Adult / ISRS	The Justice Support Services (JSS) and Integrated Support and Recovery Services (ISRS) sections worked throughout the month of March to collaboratively envision the future of the “Fresh Start” program, started in 2017 under a Federal Second Chance Act grant. This collaboration takes the known gaps between the mental health/substance abuse systems and the criminal justice system and intentionally bridges those gaps, bringing needed mental health and substance abuse services to those who find themselves in the criminal justice system.
