**HS Director Update:** Serena Pelosa shared that La Crosse County Human Services has been awarded one of the \$350,000 Wisconsin Deflection Initiative Funding will be utilized for housing support, as well as wraparound supports to expand the deflection efforts through the Pathways Home Initiative.
