COVID-19 Update

<u>Testing:</u> We continue to complete testing for staff and residents as recommended by the State and federal government, local Public Health, and our Medical Director. The State of Wisconsin has provided us with testing kits and a lab to process our results for our PCR testing which has generally been considered the gold standard for COVID-19 testing. Since these tests cost approximately \$100/test, this support by DHS has been very helpful as we are currently testing all staff 1 – 2 times per week during routine testing and every 3-7 days when we are in outbreak. Mass testing of our residents occurs only when we are in outbreak. We have used the antigen test kits provided by CMS to supplement both our routine and outbreak testing and to rapidly identify and isolate symptomatic residents and staff.

<u>Vaccination Clinics</u>: The Lakeview/Ravenwood staff and residents will receive their first dose of the COVID-19 vaccine on Friday, January 8th. Walgreens Pharmacy is the vaccinator for our campus and has scheduled three clinics at each location. At the end of these nursing home clinics, Walgreens will schedule and complete vaccinations for our assisted living residents and staff.

Resident Engagement/Visitation: This pandemic has impacted the lives of our residents to a significant level.

Isolation and loneliness are as big a factor as maintaining physical health and safety. Family involvement in the daily lives of our residents has been dramatically altered. We have tried to be very creative in helping our residents maintain contact and relationships with those they care about. Visits are person-centered and include everything from frequent phone calls, virtual web-based visits such as Face Time or Skype, window visits, outdoor visits, compassionate care visits, drive by birthday parties, and modified indoor visits. The State and federal guidelines for visitation include directives for type of visit depending on community positivity rates, outbreak status, staffing, and other factors. We remain committed to assisting our residents in maintaining these important relationships.

Our indoor visits will open this month once we get out of outbreak status and if the county positivity rate remains low.
