Lakeview Health Center & Assisted Living continues to follow guidance from our State and local resources to best manage our long term care settings. We want to take a minute to share with you the many strategies we have implemented to keep our residents and staff as safe as possible.

Resident Interventions:

- 1. Active monitoring of temperature, lung sounds, respiratory status two times per day for each resident
- 2. Encouraging and assisting all residents to wear a mask and/or face shield when out of their room, social distance, and practice good hand hygiene
- 3. Modifying dining practices to provide assistance as needed while providing safe distancing, good hand hygiene and wearing of mask when not eating
- 4. Modifying activities to increase 1:1 activity engagement no group activities
- 5. Continued restrictions on visitors
- 6. Increased opportunities for virtual visits
- 7. Quarantine/testing protocols for all new admissions, for residents returning to the facility after a hospital stay, and for any resident with symptoms
- 8. Surveillance testing of all residents

Staff Interventions:

- 1. Active monitoring of temperature and symptoms
- 2. Universal source control with use of mask by all staff and use of face shield/goggles for staff when in resident households
- 3. Quarantine/testing protocols for any staff with symptoms or who has been exposed through community spread
- 4. Surveillance testing of all staff
