Minutes of Technical Advisory Committee Meeting, September 13, 2023

Minutes of the meeting of the Technical Advisory Committee held at 2:30 pm on Wednesday, September 13, 2023, in room 1107 of the La Crosse County Administrative Center and by Microsoft Teams.

Erin Duffer called the meeting at 2:31pm.

1) Approval of minutes of the July 12, 2023, Meeting:

Charlie Handy motioned to approve the minutes of the July 12, 2023, meeting; Jim Krueger seconded. All were in favor.

2) Recommendation to approve amending the 2023-2026 Transportation Improvement Program (TIP): Stephanie Sward motioned to recommend to the Policy Board to approve amending the 2023-2026 Transportation Improvement Program; Kurt Wayne seconded. All were in favor.

3) Adjusted Urban Area Boundary (AUB) for the 2020 Census update:

Erin Duffer presented to the board the draft AUB Map and provided an overview of the process. The map has been prepared in coordination with WisDOT and MnDOT.

Charlie Handy motioned to recommend to the Policy Board to approve the Adjusted Urban Area Boundary; Jim Krueger seconded. All were in favor.

4) Wisconsin STP-Urban, Rural, Local and TAP solicitation update:

Erin Duffer provided an overview of funding programs and deadlines. Wisconsin STP-Urban and TAP application deadlines are October 27, 2023. STP-U applications will be ranked by the TAC a future meeting and TAP application will be ranked by the CTAT. The funding allocated to the LAPC for the STP-U program is not known at this time. A question was asked regarding the projects needing to be ranked by the MPO prior to the application submittal deadline. It was clarified that the information was inaccurate on the WisDOT website regarding MPO ranking prior to the application deadline.

5) Local Road Improvement (LRIP) Pilot update and discussion:

Erin Duffer provided an overview of the Wisconsin DOT LRIP program. It was discussed that the LAPC will explore providing technical assistance to dues paying member local units of government in future LRIP solicitations.
