### Ordinance and Policy Highlights

1. This permit will be valid for three (3) consecutive days. Three consecutive days means 3 consecutive workdays when the La Crosse County Landfill Complex and the Resource Recovery facility are open for business. For example, Monday, Tuesday and Wednesday OR Thursday, Friday and Monday. The permit fee is in addition to the tipping fee (usage fees).
2. This permit will be valid for one (1) vehicle.
3. All refuse admitted to the landfill complex is to be completely enclosed within the vehicle, either in a packer truck, enclosed box or covered within a tarpaulin, or other acceptable covering.
4. Each permitted vehicle will have plainly marked on its left, front side, a vehicle number. If a vehicle does not have a number, the County will assign one.
5. The permit holder agrees that he/she is aware of the risks of using the La Crosse County Landfill Complex and the NSP Resource Recovery Facility and agrees to assume any and all risks and liabilities as a result of such use pursuant to this permit.
6. The permit holder hereby agrees to indemnify and hold harmless La Crosse County, its employees, agents and officers against any and all liability, costs, damages or expenses (including reasonable attorneys' fees) arising out of or relating to permit holder's use of the La Crosse County Landfill Complex and/or the Resource Recovery Facility, unless such liability or damage is the direct and proximate result of the negligence of La Crosse County.
7. Failure to comply with any La Crosse County ordinance or policy may result in enforcement action, including possible revocation of this permit.
8. Compliance of permit conditions allows, but does not guarantee, the disposal privileges at the La Crosse County Resource Recovery Facility on French Island and the La Crosse County Landfill Complex.
9. The permit holder is to leave the facility prior to closing (allow 30 minutes prior to closing to unload).
10. Permit holder affirms that required insurance is maintained on vehicle(s) entering the landfill complex.

Permit fee not required for: Clean wood, clean residential asphalt shingles, yard waste, tires, brush, clean concrete and asphalt, the County Public Drop-Off site, and such materials as modified by time-to-time by the La Crosse County Solid Waste Department.
