SHELTER RESERVATION PROCEDURES

La Crosse County offers shelter house reservations for public use in three County parks. Each shelter includes electrical outlets, volleyball net, and an open grill. Vault toilets are located near each shelter. The shelter and its immediate surrounding area can accommodate a maximum of 150 people. If the group size is larger than this amount, one shelter is not large enough and other arrangements need to be addressed.

RATE:	County Resident: Non-County Resident: Youth organizations:	The rental fee for a shelter is \$70.00 plus tax. The rental fee for a shelter is \$75.00 plus tax. The rental fee is one half the regular fee for rentals Monday – Friday.

- Reservations are accepted at the County Facilities Department beginning the first working day of each year during regular business hours.
- On the first working day of the year, reservations are accepted in person only.
- Must be at least 18 years of age to make a reservation.
- Reservations require payment in full at the time of reservation.
- After the first working day of the new year, reservations can be made in person, by phone or online.
- Reservation must be secured at least 7 days prior to use via the online system. Reservation requests less than 7 days must be made through the Facilities office and are handled on a case by case basis.
- All users of park facilities must agree to abide by the <u>Park Rules and Regulations</u> (Chapter 19 of the La Crosse County Code of Ordinances.)
- We continue to ask that all park users make decisions regarding park use with staying healthy in mind.
 - Stay at home if you are sick.
- Minimize close physical contact with those outside of your household.
- Bring your own hand sanitizer and disinfectant wipes.
- Vault Toilets and Water Hand Pump are NOT sanitized on a regular basis. Use a glove or your elbow to avoid common touching sites and/or hand sanitizer or disinfectant wipes if touching can't be avoided
- Cancellation Policy: No refund if cancellation request is received less than 14 days prior to date of use. A partial refund (50% of fee) will be issued for cancellations received 14 days or more prior to date of use.
