Bev reported on a conversation she had with a representative from a bicycling group regarding the Iron Overhead Truss Bridge, and his interest in extending the bike path along Highway 16, and having the bridge moved to be part of the bike path. Discussion was held regarding the parties who should be consulted. Barb suggested talking with the Town of Hamilton Board as a first step, and also talking with the McGilvray Road group that had a historic bridge moved to the Van Loon Preserve, and lobbying the DOT. Vicki asked if the Commission would still like to proceed with the nomination. The consensus was that it should proceed, and Vicki will talk to Corporation Counsel about a Resolution to go to the Planning, Resources, and Development Committee as a first step toward County Board approval.

# UPDATE ON PALMER LEWIS OCTAGON HOUSE NOMINATION

The Commission reviewed the information that was provided by Errol Kindschy on the octagon architecture. **MOTION** by Schuppel/Loomis to nominate the Palmer Lewis Octagon House as a Historic Site in La Crosse County. **Motion carried unanimously.** Notice of a public hearing will be published twice in the *La Crosse Tribune* prior to holding the hearing at the May 7, 2010, meeting. Notification will be sent to Errol Kindschy.

# UPDATE ON GRANT FROM WISCONSIN HISTORICAL SOCIETY

A grant was awarded in the amount of \$7,500.00 to nominate the Oehler Farmstead to the National Register. Barb reviewed the process going forward: The Wisconsin Historical Society is currently advertising for a qualified historic preservation professional to research and prepare the necessary paperwork. That application deadline is April 5, 2010. The applications will be forwarded to the Commission, and the Commission may then choose a consultant. The consultant will submit progress reports and invoices. The invoices are paid to the consultant, and the Commission asks for reimbursement from the Wisconsin Historical Society.

## DISCUSS IDEAS FOR AN EDUCATIONAL PUBLICATION

Vicki asked if the Commission still wished to consider producing an educational booklet. Discussion was held regarding alternatives that could be considered, e.g. revising the brochure, and transferring the budgeted amount for another use. Consensus was that the item could be removed from the agenda for consideration in 2010, and be reconsidered in the future. Discussion was then held about bookmark distribution. In addition to sites previously identified, they will be provided to the Onalaska schools, the UWL library and research center, and the Onalaska tourism center and LACVB.
