UPDATE ON OEHLER FARM NATIONAL REGISTER NOMINATION

A copy of the contract with the Wisconsin Historical Society, historic preservation consultant Tim Heggland, and the La Crosse County Historic Sites Preservation Commission, was distributed.

DISCUSSION REGARDING NATIONAL REGISTER NOMINATION WITH REMAINING FUNDS

Since the Oehler Farm nomination project will come in at less than the full grant amount, the Chair spoke with the State Historical Society about use of the remaining grant funds. They indicated that remaining grant funds totaling \$3,500.00 could be used for another nomination. Discussion was held regarding a nomination of the Swarthout House and Neshonoc Dam, including property ownership and procedure for contracting with a historian. **MOTION** by Mach/Holley to pursue National Register nomination of the Swarthout House and/or Neshonoc Dam with remaining Wisconsin Historical Society funds. **Motion carried unanimously.**, The Chair will contact the WHS to see if those two properties are worthy of NRHP status.

UPDATE ON DESIGNATION OF WRIGHT FARM AS A LA CROSSE COUNTY HISTORIC SITE

The Chair checked with the Finance Department on use of printing funds for designation plaques. She reported that it would be alright to do so, and she'll provide a draft design for approval at the next meeting.

RESOLUTION RE: DESIGNATION OF THE PALMER/LEWIS OCTAGON HOUSE AS A LA CROSSE COUNTY HISTORIC SITE

The Resolution states that the Palmer/Lewis octagon house is a historic site in La Crosse County, and is on the National Register. The structure remains intact, and features the unique architecture of an octagon house. **MOTION** by Holley/Loomis to approve the Resolution Re: Designation of the Palmer/Lewis Octagon House as a La Crosse County Historic Site. **Motion**

carried unanimously. The Resolution will next go to the Planning, Resources & Development Committee at its August 30, 2010, meeting.
