# **APPROVE MINUTES OF JUNE 24, 2010**

#### AGENCY REPORTS

Leanne Hedberg Carlson, with Emmy Carlson, owner of The Root Note café, reported on La Crosse Food Future at the Hillview Greenhouse Life Center. The greenhouse serves the elderly community by growing fresh, organic produce. She stated that the organization is in a transition phase, and is writing a strategic plan, which includes establishing an urban agriculture center. One of their goals is to educate low income people on growing high yield plants in small spaces. She reported on cooperation and support from City of La Crosse Zoning, UW-La Crosse, Western Technical College, Coulee Partners for Sustainability, and Gundersen Lutheran. She answered questions regarding partnerships, grant funding, and timelines.

#### **BASELINE COMMITTEE UPDATE**

Rob Tyser reported that the goal of the committee is to document and monitor gas and electric use for the City and County and show how it has been decreased with sustainable practices. Xcel Energy provided two spreadsheet files for a year of consumption history data. The committee is assessing the data for quality and completeness. Discussion followed regarding the complexity of the information, and the need for storing data. Wayne Olson requested committee endorsement to talk to the County Finance and/or Information Technology Departments about a data repository to store and protect original information, which could then be accessed for various studies and comparisons. **MOTION** by Giese/Tyser to authorize a representative from the Baseline Committee to approach one or more La Crosse County departments to explore opportunities to create a database and review account numbers. **Motion carried unanimously.** Johnson, Konkel excused.

#### **GREEN CERTIFICATION POLICY UPDATE**

Rob Tyser reported that preliminary work has been done. A full report was referred to the August 26, 2010, meeting.

#### WEBSITE COMMITTEE UPDATE

Karl Green stated they are working on the website front page. He stated that the web designer, Michelle Jensen, is looking for graphics and subsets.
