## COUNTY ADMINISTRATOR REPORT – Steve O'Malley

- **WCA Legislative Exchange:** This event will be held on February 9 and 10, 2010. Anyone interested in attending should contact Chair Doyle's assistant. Some committee meeting dates may need to be changed to accommodate those who will be in Madison.
- **High Speed Rail:** On Saturday, January 23<sup>rd</sup> representatives from both sides of the river will be traveling to an event in Milwaukee and holding press conferences along the way to promote bringing the High Speed Rail through our area. They will attend the Timber Wolves / Bucks game and hope to get an audience with Senator Kohl. Administrator O'Malley has the information for any that are interested. All expenses will be the responsibility of each participating individual.
- **Dioxins and Waste to Energy:** Solid Waste Director Hank Koch spoke, with the aid of a power point presentation, about Dioxin, Waste to Energy (WTE) and Plastic Recycling. His purpose is to inform and educate on these important issues.
  - Overview

What is Dioxin? Dioxin emissions past and present

- A group of 17 chemical compounds with highly variable toxicity.
- The EPA has classified dioxin as "a known human carcinogen" based on wild animal studies
- Municipal waste incineration has gone from being the primary source of dioxin (56.8%) in 1987 to only 1.4% in 2000.

WTE compared to coal plant emissions

 The EPA has concluded that WTE power plants produce electricity "with less environmental impact than almost any other source of electricity." WTE is considered a minor source of mercury and dioxin compared to coal

Greenhouse gas emissions (GHG)

- Our system has the lowest GHG emissions since electrical production no longer comes from coal, we have no long hauls so most vehicle emissions have been eliminated from the process, we produce less methane and have been doing recovery and diversion.
- Is WTE Green? Yes, because of the following:
  - Waste stabilization
  - Avoids long haul transport; Lessens reliance on fossil fuels
  - Provides long-term control over disposal capacity and pricing
  - Provides base load renewable energy
  - Complements source separation recycling programs
  - Have the opportunity for cogeneration
  - Is cleaner than coal or oil
  - Minimizes landfill disposal impacts

Should we recycle plastics?

• Probably, but it will not have a significant effect on either the landfill space or the Xcel tonnage, nor will it impact dioxin production.

What does this mean to us? La Crosse County is on the right track.

- Hierarchy of waste management
- GHG (Green House Gases) reduction
- Long term future is more secure
- The investments made by the County have paid off in that they have reduced dioxin emissions

In Mid 2010 the Wisconsin DNR will do an independent and comprehensive multipathway risk assessment on Xcel Energy. This will tell us how we are doing and will influence future processes. To improve recycling programs Solid Waste Director

Koch suggests a regional approach for evaluation, recycling on a larger scale and the possibility of alternative funding mechanisms

- Equalized Value Apportionment Data: With the aid of slides and charts Administrator O'Malley demonstrated how property assessments affect property tax. The current tax assessment system does not fairly account for true value. The system has no standards and lacks professionalism. Because some assessments are late or incomplete and/or inaccurate there is no consistency in equalized value. This is key to distributing the County tax across the municipalities. That is why some municipalities see a jump in their portion of the County tax and others see misleading decreases, only to "catch up" in following years. La Crosse County's Resource Agent, Karl Green, has a very informative presentation that some supervisors have seen and others may find interesting as well. Administrator O'Malley thought that would tie in very well with the presentation given at the recent Collaboration Conference which was also very educational. He proposed a joint meeting with the City of La Crosse at our February Planning Meeting which could start a little early to accommodate both presentations.
- Administrator Evaluation and 2010 Work Plan: Administrator O'Malley asked all supervisors to fill out his evaluation and 2010 Work Plan and turn it in to the Chair.
