Chair Burke brought up the opportunity of holding an opening prior to a town hall meeting on March 3, 2011, to be sponsored by WKBT and the *La Crosse Tribune*. Committee consensus was that a separate event would bring attention to other important aspects of the LEC project, including the cost savings to the tax payer by controlling debt service and the levy, and the sustainable features that were incorporated.
