MINIBUS ESTABLISHING AGENCY RATES

An agency rate will reflect the actual cost of a trip which will be used when other agencies, such as Medical Assistance, Western Wisconsin Cares, Logisticare, request transportation for their consumers. The fares for the MiniBus, \$3.50, \$4.00 and \$4.50 respectively for zones 1,2,3, reflect a subsidized fare with the county and the WI DOT providing the majority of the funding. If, for instance, Medical Assistance wanted to send their consumer on the MiniBus and paid only the fare then s85.21 Elderly & Disabled Transportation would actually be subsidizing Medical Assistance. This is prohibited under s85.21 regulations. Noreen will consult with Bill Shepherd, Corporation Counsel, prior to the next meeting to make sure he approves the agency fare as appropriate.
