PUBLIC HEARING ON THE NOMINATION OF THE MIDDLE RIDGE SCHOOL AS A HISTORIC SITE IN LA CROSSE COUNTY

Chair Twinde-Javner opened the public hearing at 9:02 a.m. Bev Mach called upon the members of the Middle Ridge School group that were present to speak about the history of the school. Arlene Schmidt stated that she and 13 siblings attended school there, and it was where the oldest children learned to speak English. When the school needed teachers, the school board asked nuns to take over teaching, which created a unique situation of public-parochial cooperation. Ann Hundt and Jeanette Hammes stated their husband's attended school there. The Middle Ridge school and grounds are being faithfully restored. The Chair closed the public hearing at 9:09 a.m.

APPROVE THE MIDDLE RIDGE SCHOOL AS A HISTORIC SITE IN LA CROSSE COUNTY

MOTION by Mach/Loomis to approve the Middle Ridge School as a historic site in La Crosse County. **Motion carried unanimously.**

PUBLIC HEARING ON THE NOMINATION OF THE STRIPED SCHOOL AS A HISTORIC SITE IN LA CROSSE COUNTY

Chair Twinde-Javner opened the public hearing at 9:10 a.m. Phyllis and Norman Berg and Linda Saley gave comment on behalf of the nomination. Mrs. Berg was a teacher at the school, and the school is on land owned by the Bergs. Ms. Saley attended the school. The school has been at the same site since 1859. They are concerned about the nearby creek encroaching on the building, and would like to move the school to a concrete slab. They are working with the County Zoning Department on a variance. It is one of the oldest school structures in Burns Township. Barb Kooiman stated it could be the oldest existing schoolhouse in La Crosse County. The Chair closed the public hearing at 9:19 a.m.

MOTION by Loomis/Schuppel to approve the Striped School as a historic site in La Crosse County. **Motion carried unanimously.**
