7) Boating Rules Brochure

- Reported 1000 brochures were printed and distributed to City of La Crosse, La Crosse County, Town of Campbell, Town of Shelby, LACVB, etc.
- City and County will split cost of brochures.

8) No-Wake Zone Signage

Larry has 17 no-wake zone signs that could be either temporarily or permanently placed.

- Symbiotics is proposing hydropower on Pool 8
