COMMUNICATIONS AND ANNOUNCEMENTS:

County Board Chair Report - Steve Doyle

- County Clerk Interviews: There were 26 applicants. On January 26^{th,} at 1 PM, the Executive Committee will be reviewing the applicants to narrow those down on whom to interview. Interviews will take place on February 1st 2011 at 1 PM. Any supervisor is invited to attend and encouraged to join the Executive Committee during interviews. Chair Doyle announced he will not be participating in the interview process since one applicant has also expressed interest in running for the 94th Assembly District. Chair Doyle and Administrator O'Malley responded to questions from the board. More than one candidate can be brought to the board for approval if the Executive Committee deems appropriate to do so.
- Reminder: Mileage/Travel reimbursements for 2010 need to be turned in before February 1st.
- There are a number of vacancies on committees and boards. If you know of anyone who is interested, please notify the Chair's office. Library board 1 citizen member vacancy, Harbor Commission 1 vacancy, Equal Opportunities in housing 1 vacancy, Highway Commission has two vacancies appointment comes from Sheriff Department. Committee focuses on safety issues, notify Sheriff Department for that. Winding Rivers Library System 1 vacancy.
- Supervisor Conference Reports:
 - Supervisor A. Benrud presented a plaque from the State of a Resolution of Service to retired Highway Commissioner Dennis Osgood. To a round of applause and a lengthy standing ovation, Dennis thanked the Board for the support he has been given over the years.
 - Supervisor G. Sebranek traveled to Tomah on Monday with A. Benrud, Steve Peters, and Jim Ersham to meet with Ed Thompson, who is suffering from an illness, to present him with a velour comforter with an ITBEC logo embroidered on it.
 - Supervisor V. Burke brought to the attention of Supervisors a check displayed up front from Focus on Energy presented to La Crosse County for the amount of \$128,144.00. Supervisors Berns, Ebert, Freedland, Mach, Medinger, Hampson and former Supervisors Ann Fisher, Tom Rauk, and Joe Veenstra have all served on the committee and put in a lot of work for the Law Enforcement Construction. A copy of the speech John Heck gave at the presentation was on each Supervisor's desk. Congratulations to the County Board for their interest in sustainability in La Crosse County.
 - Supervisor L. Pfaff attended the Highway Winter Road School and Conference. One of the highlights was the new Secretary of Transportation who was there to speak of what the future looks like, which is not very bright for road funds. One option might be raising the gas tax. He also talked about how the administration is in favor of getting the segregated funds through legislature. It has to go through legislature two consecutive times and then can be put on the ballot in 2013 at the earliest. Of the 54 or 56 counties that had the referendum on the ballot, it passed with an average of 70% approval rating.
 - Supervisor J. Billings was at the Capital on Wednesday with Supervisor Schroeder, they met with other Supervisors on the County Ambassador Program and learned about issues they advocated for at the Capital and had appointments and were able to talk with Rep. Schilling and Sen. Kapanke's staff person. Issues that were highlighted by WCA that we advocated on included the Juvenile Correction Institution closing one of the facilities for boys because the population doesn't justify two facilities, talked about mandates and suggested changes that would make things easier on counties, probation and parole holds, reimbursement and asked for an audit on probation and parole to make sure the number of people in our facility is

really justified. They will be going back on April 4 to advocate on Human Service issues.

Administrator Report - Steve O'Malley

- County Administrator's Work Plan follow-up: Evaluation and Mgt. Team meetings:
 - Included in your packet is the standard evaluation form. The Executive Committee decided to use the same form as in the past and to please return it to the Board Chair's office in the next two weeks. Chair Doyle encouraged supervisors to fill out and turn in after the meeting. O'Malley suggested including any feedback you have whether good or bad. One item not included is the Highway Commissioner interviews. We have an exciting group of candidates. First interviews of 6 or 7 candidates will be with County staff and 2nd interview with 2 or 3 candidates will be with the entire PWI Committee on February 10th after Executive Committee meeting. They hope to bring a name to County Board on February 17th for approval if possible.
 - Management team is an internal administrative workgroup he has had for a 0 number of years. It is an extension of the Department Head workgroup that includes Finance, Personnel, Corporation Counsel and Human Services. They meet monthly about issues coming up to make sure they stay on top of things coming to the County Board. A year ago he started inviting the Board Chair to keep him up to date on what's going on and it's a good way to make sure issues are in front of you and moving ahead. Administrator O'Malley decided this year to add IT and Facilities to this group and proposed adding 1st and 2nd vice chairs to make sure they are on board with what is coming back to County Board, issues that are being anticipated, and how we handle items Supervisor Burke has concerns that are coming through the process. regarding elected officials being on the management workgroup. There is a definite authority and structure as far as boundary management. The board sets policy and the Administrator is the link between staff and County Board. A strong point for the workgroups is not having elected officials on there. Chair Doyle stated that this is a communication tool and he is there as a Department Head. Within that group, if one member is not able to show up, there is a back up. It's not a decision making body as much as it is a communication tool. Occasionally he has noted that certain issues need to be brought up to the Board during these meetings. Department heads have a fill in person, so should Board Chair. Concerns regarding the open meeting law was discussed. Lengthy discussion ensued. Motion by G. Sebranek/J. Bilskemper to limit debate to only being allowed to speak once failed on a voice vote. Discussion continued. No vote was taken.
- Update on Resolution Re: Determination of Necessity to Acquire Schroeder Property on State Road 16: He has asked both committees for an additional 30 days. They are working on getting input from adjacent land owners. Under the plan, there will be three developable parcels in the City of La Crosse as well as potential developable land in adjacent part in Onalaska. Administrator O'Malley responded to questions from the Board. A complete plan with recommendation and facts involved will be brought back to the County Board.
- Update on Park Plaza: Nothing new to report just yet. There is a tentative agreement with adjacent landowners which will be presented through the committee process for joint marketing. No proposals were received for joint marketing from marketing firms. We are trying to ascertain why we didn't get any proposals. Charlie Handy is meeting with adjacent landowners and what that means for our next steps. Three items to deal with in Park Plaza: joint marketing agreement with adjacent landowners, marketing by an outside firm, and agreement between City and County. Marketing proposals were sent out to several firms from out of State and throughout the Midwest if not farther for proposals.
- Reminder of March 3rd Criminal Justice Town Hall meeting: Criminal Justice Town Hall meeting will be at 7pm on March 3rd. Preview will happen at February 21st Policy Planning Meeting. Please let Administrator O'Malley or County Clerk know if you plan

CONDITIONAL USE PERMIT NO. 821 FILED BY FRED W & ELIZABETH SCHOMBERG, TO AMEND CONDITIONAL USE PERMIT NO. 422 TO ALLOW CONTINUED TOP SOIL STOCKPILES, REMOVAL AND SALE ON APPROX. 9.0 ACRES OF LAND ZONED EXCLUSIVE AGRICULTURE DISTRICT IN THE TOWN OF BARRE

The La Crosse County Planning, Resources and Development Committee, having considered the application filed by: Fred W & Elizabeth Schomberg, W3796 Loging Rd, West Salem, WI 54669 and having held a public hearing on the 3rd day of January 2011 for a Conditional Use Permit to amend Conditional Use Permit No. 422 to allow continued top soil stockpiles, removal and sale on approx. 9.0 acres of land zoned Exclusive Agriculture District in the Town of Barre on land described as follows: Part of the S¹/₂-NW of Section 33, T16N, R6W, Beginning at the NE corner of the SW-NW thence south along the East line 300' to the POB; thence West 250', thence South 450', thence East 850', thence North 450', thence West 600' to the POB. Together with an existing haul road access. Town of Barre. And pursuant to s. 59.69 Wis. Stats. and s. 17.36 Zoning Code: the Committee did publish and receive proof of a Class II notice of the hearing; did receive receipts of mailing of the notices to the affected Town Clerk(s); did hold a public hearing to hear testimony or correspondence from the people; and, did receive and consider action from the affected Town Board(s). The Committee and the affected Town Board(s), under s. 17.36(4), have the authority to approve the application with integral conditions or to disapprove of the application. Having considered the entire record the Committee's recommendation is to: Approve with conditions. By a vote of <u>6</u> in favor (<u>1</u> excused-Keil) the Committee recommends approval of this permit for topsoil removal, subject to the following five (5) conditions:

- 1. This permit is granted to allow for topsoil removal, sale and stockpiling on a 450-ft X 850-ft parcel together with a haul road for ingress/egress;
- 2. An approved erosion control permit is required to prevent water run-off from the site;
- 3. Anytime the total disturbed area accounts for more than 1.0 acre, the parcel and owner will be subject to an after-the-fact Non-Metallic Mining Permit;
- 4. This permit terminates Conditional Use Permit No. 422 in its entirety; and
- 5. This permit is non-transferable.

Any deviation or alteration of the conditions set forth in this permit shall constitute a violation of the terms of this Conditional Use Permit and shall be subject to prosecution and penalties under the terms of this Ordinance. A new public hearing and permit must be granted to extend or alter any of the conditions set forth herein. **The County Board** took

The La Crosse County Planning, Resources and Development Committee, having considered the application filed by: Paul Kammel; acting on behalf of Kammel Custom Excavating LLC, N975 Broadhead Rd, La Crosse, WI 54601; acting on behalf of Duane, Paul and Terry Kammel and Linda Walker, N1004 Broadhead Rd, La Crosse, WI 54601 and having held a public hearing on the 3rd day of January 2011 for a Conditional Use Permit for an after-thefact permit to operate an excavation business with soil stockpiles; 5 dump trucks, 3 dozers, 3 backhoes, 1 tractor hoe, 1 compactor, 6 trailers, 2 semis, 1 grader and 2 pickups which includes 2 storage buildings and outside storage on land zoned Exclusive Agriculture District in the Town of Greenfield on land described as follows: The NW-SE of Section 20, T15N, R6W, EXCEPT Lot 1 of Certified Survey Map No. 92, Volume 1. Town of Greenfield. And pursuant to s. 59.69 Wis, Stats, and s. 17.36 Zoning Code: the Committee did publish and receive proof of a Class II notice of the hearing; did receive receipts of mailing of the notices to the affected Town Clerk(s); did hold a public hearing to hear testimony or correspondence from the people; and, did receive and consider action from the affected Town Board(s). The Committee and the affected Town Board(s), under s. 17.36(4), have the authority to approve the application with integral conditions or to disapprove of the application. Having considered the entire record the Committee's recommendation is to: **Approve with Conditions.** By a vote of $\underline{6}$ in favor (<u>1</u> excused-Keil) the Committee recommends approval subject to the following fifteen $(\underline{15})$ conditions:

- 1. The County Land Use Plan indicates this property should remain Agriculture and Rural Residential, therefore, these conditions must be held to this strict use considering the size of the business and equipment;
- No topsoil or borrow materials may be taken from this site. It appears two (2) borrow sites have been disturbed along the northerly property line. The site furthest east can be used to stockpile clean gravel, breaker concrete but no asphalt of any kind. This easterly site can also be used to store workable equipment;
- 3. Nowhere on the farm can inoperable vehicles or junk equipment be stored;
- 4. This permit allows for an excavation business and storage of licensed and operable equipment in the area depicted on the application surrounding the existing buildings and 150-ft southeasterly of the private driveway;
- 5. After-the-fact Zoning/Occupancy Permits are required for the three (3) existing farm buildings that were converted to commercial use;
- 6. No part of the existing home or garage may be used for this operation;

- 7. The DNR shall be contacted by the applicant for proper containment of the three (3) fuel tanks adjacent to the residential garage;
- 8. Absolutely no fluids or hazardous materials are allowed on the ground but in properly permitted and marked containers. An approval letter from the DNR is required for our files;
- 9. A letter from the La Crosse County Environmental Health Department is required for our files indicating proper restroom facilities exist for employees;
- 10. All equipment owned or leased, shall be reported yearly to the local assessor. The Town shall go back 2 years to assess this equipment as omitted property.
- 11. The Paul Kammel parcel does not have an easement to their single family residence. An easement shall be recorded in conjunction with the Duane & Sandra Kammel private drive easement that indicates there is a maintenance agreement between the excavation business and private residences;
- 12. Clean gravel and recycled asphalt may be stored between the two (2) larger commercial and maintenance sheds;
- 13. Off-street and off-easement parking is required;
- 14. This permit is non-transferable; and
- 15. If any of these conditions are not met, this permit is subject to termination.

Any deviation or alteration of the conditions set forth in this permit shall constitute a violation of the terms of this Conditional Use Permit and shall be subject to prosecution and penalties under the terms of this Ordinance. RESOLUTION NO. 73-1/11 RE: INCREASING HOURS OF NUTRITION EDUCATOR BY .07 FTE – 2.6 HR/WEEK

WHEREAS, the Health Department has received a WIC contract allocation from the state for 2011 that is \$32,165 more than anticipated in the 2011 budget, the increased funding to

provide additional nutrition services as directed by the state; and, **WHEREAS**, a slight increase in existing nutrition education staff time is necessary to fulfill the contract obligations; and, **WHEREAS**, an existing Nutrition Educator would need to be increased from .93 to 1.0 Full Time Equivalents, which does not increase existing employee benefits; and, **NOW THEREFORE BE IT RESOLVED**, that the Health Department is authorized to increase the hours of one existing Nutrition Educator from .93 to 1.0 FTE for the length of the WIC contract. **FISCAL NOTE:** The WIC contract (federal funds through USDA) has increased from \$418,000 to \$451,000; the cost of the additional hours is: \$3997 wage, \$306 FICA and \$464 WRS for a total of \$4,767. Remaining funds will be used to meet contract objectives including indirect maternity leave and other WIC contract related expenses.

HEALTH & HUMAN SERVICES BOARD EXECUTIVE COMMITTEE
