MHRS NAME CHANGE

Jen Timm reported with the substance abuse section moving back to MHRS, we are considering a name change, which will incorporate substance abuse services into MHRS. A couple of suggestions have been Mental Health and Recovery Services or Integrated Care Services.

OFFICIAL BUSINESS

Jen Timm introduced Christin Skolnik as the new CCS Supervisor. She previously was a CCS Service Facilitator. Before she joined the County, she was employed at Family & Children's Center as a CSP social worker. Christin will cover the CCS/COP business in the near future in this council.

MHRS UNIT PRESENTATION – Crisis/Short-Term System

Donna Christianson gave a PowerPoint presentation on crisis follow-up and how it overlaps with other MHRS services. Crisis contacts average 5000 a year. This has drastically increased over the years. 44% of crisis referrals are self-referrals; the others are law enforcement/jail, community and hospital. We have next-day crisis appointments available with our CRISIS therapist. Short-term case management is available. If more time is needed, a referral to a longer-term program is made.

ITEMS FOR FUTURE AGENDAS

In January, agenda topics include MHRS name change, further updates regarding adult/youth CCS stem changes, any official CCS business and discussion around how MHRS will seek out consumer feedback in 2013. A possible future agenda item when it is the CRISIS program's time to present will be how CIT training is used in the CRISIS program. The focus next month will be on CCS/COP.
