2. French Slough No Wake Zone Public Informational meeting (public comments welcomed)

- Tom Weiss (2525 Baumgartner Dr.) Property damage especially during high water
- Dave Eilertson (2611 Baumgartner Dr.) Property damage
- Mike Olson (2527 Baumgartner Dr.) More high powered boats b-line to main channel/I-90 bridge
- Dyanne Brudos (2529 Baumgartner Dr.) Safety fishing kayaking
- Bob Sargent (2533 Baumgartner Dr.) Erosion and then trees begin to have roots exposed and collapse. On-going situation with moving docks
 - Glena Temple (2623 Bayview Ct.) Significant speeds on French slough
 - Discussion on number of buoys, who places buoys, etc.
 - Marc discussed local regulations necessary for public safety concerns
