PROCLAMATION OCTOBER 2012 - SOLID WASTE AND RECYCLING MONTH WHEREAS, dedicated nationally recognized County professionals help to minimize our county's impact on the environment by effectively managing waste through award winning programs; and, WHEREAS, La Crosse County solid waste programs in part include wasteto-energy, permanent household hazardous materials collection, asphalt shingle recycling, treatment of petroleum impacted soils, and trailer home recycling; and, WHEREAS, La Crosse County's solid waste program has achieved Green Tier status and is recognized by the Wisconsin Department of Natural Resources for having superior environmental performance. WHEREAS, in addition to these programs, La Crosse County facilitates local and regional collaborative efforts in managing waste through shared recycling newsletters, mobile collection of household hazardous materials, access to the waste-to-energy program, and solid waste planning; and, WHEREAS, La Crosse County has shown its commitment to further enhancing solid waste and recycling efforts through sustainability practices which will be coordinated by the County's sustainability coordinator; and, WHEREAS, residents benefit from the cost savings, improved service and enhanced sustainability that result from intergovernmental collaboration at all levels of government on solid waste and recycling collection, processing and beneficial reuse of by-products; and, WHEREAS, all residents have an on-going responsibility to participate in sustainability through decreasing the amount of garbage that is produced in our homes, schools, communities, and work place by practicing waste reduction, recycling, and buying recycled products. NOW THEREFORE BE IT RESOLVED, that the La Crosse County Board does hereby proclaim the month of October 2012 as La Crosse County Solid Waste and Recycling Month and urges all residents to join in recognizing the valuable contribution of persons dedicated to the welfare of La Crosse County residents.

Motion by A. Londre/K. Johnson to approve passed on a unanimous voice vote with 24 ayes, 4 excused - S. Doyle, T. Johnson, L. Pfaff and T. Wehrs and 1 vacant – District 11.

- 2013 Budget Status Update
  - The main achievements of the 2013 recommended budget: after 3 years of 0% operating levy, this budget would increase operating levy by 1.15%, leaving operating rate at \$3.13, which is \$482,000 below limit and 5<sup>th</sup> lowest per capita; \$400,000 increase to Highway maintenance and \$4.9 million for County Road OA project; and the 2013 budget sets the stage for future decisions on jail staffing or Highway maintenance, future of Lakeview who we serve sizing and location, administrative building planning, and increase Highway funding but much more is needed. 2013 gross expenditure is \$137.6 million and 22% of that is supported by property taxes tax levy.
  - 2013 Budget Overview: To achieve 0% increase, impact is spread across all departments but not an equal % across the board. Position attrition in many departments and success by Human Services department were critical to shifting of resources to Highway. There was no increase in health and dental premiums and a 2% wage increase. Reliance of Fund Balances applied was only moderate and not highly reliant on increased user fees.
  - 2012 & 2013 Board Decisions: Administrative building evaluations of options

     architectural and engineering services for 2013 and bonding for remodel or replacement; Highway capital projects and increased maintenance; and examine Highway options for 2014 and beyond.
