BOARD EDUCATION

Rebuilding for Learning Initiative

Troy Harcey is the Associate Superintendent of Instruction at the School District of La Crosse and he presented on the Rebuilding for Learning Initiative which is a collaborative effort formed by the School District of La Crosse, County of La Crosse, and City of La Crosse. Dr. Harcey's goal is to get the word out on this collaboration and keep the community thinking about how we can collaborate together to create the conditions that our young people need to flourish.

Dr. Harcey shared the results of a recent feedback survey of students (grades 6-12) in the School District of La Crosse. The survey reported multiple statistics including 64% being bullied within the last year, 12% do not feel safe in school, 10% do not feel safe in their neighborhoods, and 4% do not feel safe at home. Specific comments by students were also captured in this survey.

Two Rebuilding for Learning Summits have been held over the past couple of years attended by many community agencies that work with children and families coming together with the school district, county and city to discuss issues and identify barriers to learning. A summary of the summits included identification of students' barriers to learning, what services agencies offer to address these barriers, what are embedded institutional barriers, and general feedback. As a result of the information gathered at the summits several workgroups have been created to begin working through some of the barriers identified. Dr. Harcey shared a video from the 2011 summit, including a testimonial of a student that had been in the system from a very early age.

Dr. Harcey outlined the six content arenas for a component to address barriers to learning:
1) Classroom-Based Approaches, 2) Support for Transitions, 3) Home Involvement and Engagement in Schooling, 4) Community Outreach for Involvement and Collaborative Support,
5) Crisis Assistance and Prevention, and 6) Student and Family Assistance.

The next Rebuilding for Learning Summit is scheduled on August 13, 2013. The goal is to have a collective representation from many organizations in attendance to hear reports and information stemming from the subgroups/content arenas identified.

Policy, Practice, People of Human Services Family & Children's

Nancy Pohlman (Family & Children's Manager) and Sara Halvorson (Social Worker in the Children with Special Needs Unit) introduced foster parents Katrina and Tom Allen who presented on the unique challenges they have encountered as parents of special needs adopted children. The Allens have five children of their own, and in 2009 they adopted a sibling group of three special needs children (ages 4, 7, and 10) whose parents were significantly impaired with mental health and addiction issues. The children have severe emotional and behavioral disabilities and attachment issues that are evident at home, school and within the community related to the trauma they had been exposed to by their birth parents. The Children with Special Needs Unit at the county offers services that this family needs to stay together through the trauma informed care approach of recognizing the presence of trauma symptoms and acknowledging the role that trauma has played in their lives.

Board Orientation "Being a Client" Update

The list of board members who have signed up for Being a Client was distributed. Mormann will work with Schultz and Veenstra to identify an opportunity for each of them to participate in before the end of the year, and then report out to the January HHS Board on their experiences. Presentations will last 5 minutes and can include the staff involved in providing the opportunity to the board member. Each board member is limited to two opportunities over the next year, and two presentations to the HHS Board will occur each month.

POLICY

IT Integrated Solutions System Vendor Selection

Dean Ruppert presented on the integrated product that Human Services has been working on for quite some time now. On July 13 Human Services released a Request for Proposal (RFP) and three proposals were received by the August 24 deadline. These proposals were evaluated by an eight-person RFP Review Committee made up of a wide range of sections in Human Services as well as other county departments. The proposals were ranked in 13 different areas and a point system was applied. Based on the evaluation scores, the RFP Review Committee is recommending that the HHS Board approve Human Services to move forward towards negotiations with the intent to contract with Netsmart to provide an IT Integrated Solutions System. Implementation would be planned to begin Spring 2013 and would take 9-12 months.

This single integrated system would serve as a complete product for business and financial needs for the Department, and would replace a large number of internal systems that are currently being used in Human Services. The Department has been setting aside resources for this integrated system and have plenty of monies budgeted to cover the cost.

MOTION by Kannenberg/Berg to approve the recommendation for the Human Services Department to move forward towards negotiations with the intent to contract with Netsmart to provide an IT Integrated Solutions System. Steve O'Malley advised that County IT Director John Parshall strongly supports this request and that the process to identify an integrated system has been a team effort with the IT Department and Human Services. **Motion carried unanimously**. Johnson/Trapp/Veenstra excused; Olson absent.
