APPROVE RFP FOR TWO STATIC UNINTERRUPTIBLE POWER SUPPLY SYSTEMS FOR HHS AND LEC BUILDINGS

A memo was included in the packets from the Facilities Department regarding this request for proposal. The Facilities Department solicited RFPs for two Uninterruptible Power Supply (UPS) systems for the HHS and LEC buildings. They were graded on specifications and features, warranties and incentives, and cost. The Facilities Department is recommending two 30 kVA units from PCCS, Inc. for a total cost of \$41,549, which is budgeted within the facilities budget for 2012. **Motion** by Spiker/Doyle to approve. **Motion carried unanimously.**
